SECTION 1. BE IT ENACTED BY THE COUNCIL OF THE CITY OF
ABERDEEN, that new Section 47-1 is hereby added to the Code of the City of Aberdeen (2010
Edition as amended), to be under new Chapter 47, FUNDING OF ABERDEEN VOLUNTEER
FIRE DEPARTMENT, INC., to follow immediately after Chapter 43, ETHICS, and to read as
follows:

§ 47-1. GRANT TO ABERDEEN VOLUNTEER FIRE DEPARTMENT, INC.

5 A. COMMENCING WITH THE CITY'S 2018 FISCAL YEAR, THE CITY OF 6 ABERDEEN ANNUALLY SHALL PROVIDE GRANT FUNDING TO THE 7 ABERDEEN VOLUNTEER FIRE DEPARTMENT, INC., AS PROVIDED IN THIS 8 SECTION.

10 B. THE GRANT FUNDING REQUIRED BY THIS SECTION MAY BE MADE
11 SUBJECT TO A GRANT AGREEMENT BETWEEN THE CITY OF ABERDEEN
12 AND THE ABERDEEN VOLUNTEER FIRE DEPARTMENT, INC. THE GRANT
13 AGREEMENT MAY PROVIDE FOR THE DISTRIBUTION AND USE OF THE
14 GRANT FUNDS AND ANY OTHER TERMS AND CONDITIONS RELATING TO
15 THE USE OF THE GRANT FUNDS AND THE OPERATION OF THE FIRE
16 DEPARTMENT AS THE CITY MAY REQUIRE.

C. EACH YEAR THE CITY'S OPERATING BUDGET SHALL INCLUDE AN 18 19 APPROPRIATION FOR THE ANNUAL GRANT TO THE 20 VOLUNTEER FIRE DEPARTMENT, INC. THE APPROPRIATION SHALL BE AN 21 AMOUNT EQUAL TO THE REVENUE GENERATED BY THE CITY PROPERTY 22 TAX LEVIED ON ALL TAXABLE REAL PROPERTY IN THE CITY IN AN 23 AMOUNT OF \$.02 FOR EACH \$100 OF ASSESSED VALUATION OF TAXABLE 24 REAL PROPERTY, BUT IN NO EVENT SHALL THE AMOUNT OF THE ANNUAL APPROPRIATION AND GRANT BE LESS THAN \$260,000 OR MORE THAN 25 26 \$300,000.
