- 1. Introduction of Col. Robert L. Phillips, Aberdeen Proving Ground: Col. Phillips discussed partnering with the City on projects and community events.
- 2. Old Post Apartments PILOT Letter, Isaac Sassoon

Mr. Sassoon, representing Tryko Partners, a private equity real estate group, updated the Council on improvements to a proposition for a 30-year tax exemption agreement or a PILOT program (Payment in Lieu of Taxes) upon the purchase of Affinity Old Post Apartments.

PUBLIC HEARING:

- 1. Ordinance No. 17-O-14, Fee Schedule Revision
 - a. Mr. Bob Hartman, Paradise Road: Mr. Hartman suggested that there should be a charge by the City for any transaction fee with a credit card.

PUBLIC COMMENTS:

- 1. Ms. Theresa Spencer, Baltimore Street: Ms. Spencer spoke about the flooding on Baltimore Street, Plater Street, and nearby streets in the neighborhood.
- 2. Ms. Glenda Phillips, Market Street: Ms. Phillips said that she experienced flooding on her street as well. The City Manager said that DPW would inspect.
- 3. Mr. Bob Hartman, Paradise Road: Mr. Hartman expressed concern about the safety of children walking to school in the construction area of Rt. 22.

LEGISLATIVE SESSION:

1. Ordinance No. 17-O-14, Fee Schedule Revision

- 3. Updates from City Manager and Staff

Mr. Robertson said the State Highway Administration reported that the lines had been restriped on West Bel Air, the fencing had been replaced, the drainage would be cleared out within two weeks, and that the State forester prohibited pushing back the trees. He also reported on community meetings, bus pad construction, and improvements to the train station parking lot. Installation of the dog park fence would start by September 11, 2017.

a. Allocation of Harford County Community Development Block Grant Funds FY 2016

Ms. Grover stated that the annual allocation was approximately \$87,000. She had proposed East Bel Air Avenue sidewalk repairs. The Council had requested other areas for consideration and Ms. Grover presented information on repaving/resurfacing projects on Chesapeake Court, Schofield Avenue, Valley Road, Custis Street, and Rock Road. Council discussion followed.

A motion was made by Councilman Goodin and seconded by Councilman Taylor to approve the sidewalk repairs on East Bel Air Avenue using the Community Development Block Grant Funds. The motion passed by a vote of 5 - yes; 0 - no.

b. Preliminary Site Plan for the Beards Hill Plaza Infill Building

Ms. Grover reported that the Planning Commission gave a favorable recommendation at their last meeting and summarized property specifics. The following representatives presented further information: Mr. Steve Klein, owner/developer, Mr. Gerry Powell, Project Manager from Frederick Ward Associates, and Mr. Mark Healy, Traffic Concepts. Council discussion followed.

A motion was made by Councilman Taylor and seconded by Councilman Lindecamp to approve the Preliminary Site Plan for Infill Building at the Plaza at Beards Hill, 995 & 997 Beards Hill Road. **The motion passed by a vote of 5 – yes; 0 – no.**
