PUBLIC COMMENT:

Mr. Robert Hartman, Paradise Road, Aberdeen, MD: Mr. Hartman commented on the Harford County Water and Sewer Authority Study, MTBE law suit, and the rainy day fund.

Mayor Bennett nominated Mr. Erick C. Stone for the Board of Appeals. He would replace Councilman Smith, who occupied the position before becoming a Council member.

The nomination was approved by a vote of 5 - yes, 0 - no.

Mr. Torster reported on the snow removal operations. The Hillcrest Tower repainting project would start soon and take about 90 days to complete.

- G. Business from the City Manager
 - 1. Stadium Seats
 - a. Budget Amendment
 - b. Permission to Sole Source

Mr. Miller explained that the seats at Ripken Stadium required replacement. He anticipated the money to be reimbursed by the hotel tax.

A motion was made by Councilman Smith and seconded by Councilwoman Young to approve a budget amendment in the amount of \$28,450 from the General Fund to the

Stadium Fund and to grant permission to sole source to Veletta Industries, LLC of Pittsgrove, New Jersey.

The motion was passed by a vote of 5 - yes, 0 - no.

Mr. Miller explained that the City declined joining the Harford Water and Sewer Authority for the following reasons: property taxes would increase, the City would lose control over its economic development, lose the ability to grow long term, and lose economies of scale.

Mr. Miller clarified that there is a Rainy Day Fund for the Water Fund. The \$2 million dollars received from the MTBE lawsuit settlement was reimbursement to the City for the contamination clean up and, therefore, was placed back into the Water Enterprise Fund. The Hillcrest Town Project was funded out of this fund. The City draws other expenditures from the Fund Balance.

BUSINESS OF THE COUNCIL:

Mayor Bennett expressed his concerns over the Route 22 expansion project and how it would affect the Aberdeen taxpayers. He reported that Delegate Lisanti would be sponsoring a bill to help military communities and municipalities around federal installations faced with the responsibility of paying for the relocation of water/sewer lines for State Highway projects. It would require the use of federal funds in the relocation of public utilities.

The Mayor reported on the current status of State Highway User Revenues and that the Maryland Municipal League supported full funding to help municipalities provide needed services and repair/maintain infrastructure. The Governor had restored about fifty percent funding.
