## City of Aberdeen Council Meeting June 6, 2016

Mayor McGrady called the meeting to order at 7:00 p.m. in the Council Chambers. The prayer was delivered by Deacon Rob Armstrong, Living Hope Presbyterian Church, and the Pledge of Allegiance was led by Councilman Lindecamp.

#### STATEMENT OF CLOSED SESSION:

On May 23, 2016, the Mayor and Council held a regularly schedule Council Meeting in the Council Chambers at 7:00 p.m. All members voted by roll call in the affirmative to close the session at 7:40 p.m.

At approximately 7:45 p.m., a closed session was convened by the Mayor and Council in the second floor administrative conference room. Topics discussed were the contract for the new City Manager and a parking lot lease.

During this meeting, the Mayor and Council discussed with the Interim City Manager, the contract for the new City Manager and a parking lot lease. The Council voted unanimously to authorize the Interim City Manager to make an offer to purchase property in the vicinity of the Aberdeen Senior Center.
