The Statement of Closed Session for February 24, 2016, was read by Mayor McGrady:

On February 24, 2016, the Mayor and Council held a Special Council Meeting in the Council Chambers at 6:00 p.m. All members, with the exception of one vacancy, voted by roll call in the affirmative to close the session.

At approximately 6:16 p.m., a closed session was convened by the Mayor and Council in the second floor administrative conference room. Members present were: Mayor Patrick McGrady, Councilwoman Sandra Landbeck, Councilman Timothy Lindecamp, and Councilman Melvin Taylor. Also in attendance was City Clerk, Monica Correll.

The session was held pursuant to the Open Meetings Act, Statutory Authority Md. Code Annotated, General Provisions Article § 3-305(b): (1) To discuss the appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of appointees, employees, or officials over whom this public body has jurisdiction; or any other personnel matter that affects one or more specific individuals.

During this meeting the Mayor and Council discussed the Council seat vacancy. No action was taken at this meeting.

The meeting was adjourned at 7:11 p.m.

### **PRESENTATIONS:**

1. B&O Railroad Station Restoration Update

Representatives from the following organizations discussed the current status of the B&O Railroad Station Restoration: Richard Herbig, Historical Society of Harford County, Inc. Board of Trustees; Bob Tarring, president of subsidiary corporation managing restoration; and Jon Livesey, Aberdeen Room Archives and Museum. They reported that they had applied for a Senate bond bill, intend to reuse the station consistent with zoning, and restore the exterior. The station was eligible for inclusion in the National Register of Historic Places.

Mr. Torster explained that Harford County tipping fees (cost to dispose trash) had increased over the years. Mr. Torster provided updates on the yard waste and trash pickup schedule. He reported that the City may be able to obtain reimbursement of funds for the January snowstorm from a Presidential declaration.
