3. Updates from City Manager and Staff

The City Manager thanked the Garrison Commander, Col. Davis, and his staff for the donation of fifteen trash receptacles. He also mentioned donations toward the playground equipment at Victory Park amounting to approximately \$4,000. He and Mr. Torster would be meeting with the State Highway Administration on issues of the City.

- a. Discussion of Recommended Way Forward, Personnel Policy Manual A draft of the new Personnel Policy Manual was presented to the Council for their review and discussion at a meeting.
- b. Bid No. 17-12a, Pool Cover and Installation

Mr. Torster said that five bids were received and the lower bids did not meet the specifications: size for the pool, time for installation, warranty offered, and parts to repair the investment.

A motion was made by Councilwoman Landbeck and seconded by Councilman Taylor to award Bid No. 17-12a, Pool Cover and Installation to Clearwater Pool & Spa in Bel Air, Maryland, the most qualified bidder, in the amount of \$21,680. **The motion passed by a vote of 5 – yes; 0 – no.**
