SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that the "City of Aberdeen Budget Fiscal Year 2016-2017" adopted by Ordinance No. 16-O-12 is amended as follows:

- 1. Increase the Transfers, Dept. No. 800, appropriation for "Transfer to Stadium Fund" from \$914,461 to \$959,461.
- 17 2. Increase the Police Dept. No. 110 appropriation for "Seized Money" from \$17,000 to \$101,600.
 - 3. Increase the Miscellaneous Expenses Dept. No. 162 appropriation for "Miscellaneous Expenses" from \$80,000 to \$85,600.
 - 4. Increase the Parks and Recreation Dept. No. 180 appropriation for "Parks Maintenance" from \$56,000 to \$68,639.

- 5. Increase General Fund "Police Seized Assets" Revenue No. 40509 from \$17,000 to \$101,600.

 - 7. Increase Total General Fund appropriation from \$16,133,239 to \$16,281,078.
 - 8. Increase the Total Revenues General Fund from \$16,133,239 to \$16,281,078.
