SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that the "City of Aberdeen Budget Fiscal Year 2017-2018" adopted by Ordinance No. 17-O-11 is amended as follows: 1. Increase the Police Dept. No. 110, appropriation for "Seized Money" from \$30,000 to \$45,800. 2. Increase the Parks and Recreation, Dept. No. 180, appropriation for "Parks Maintenance" from \$85,000 to \$114,500. 3. Increase the Transfers, Dept. No. 800, appropriation for "Transfer to Capital Projects Fund" from \$2,793,958 to \$2,843,958. 4. Increase the appropriation for "Public Works Administration Storm Drains" expenditures in the Capital Projects Fund from \$0 to \$29,000. 5. Increase the appropriation for "BRAC Zone Improvement Projects" expenditures in the Capital Projects Fund from \$0 to \$29,604.

- 1 6. Increase the appropriation for "General Government Capital Projects" expenditures in the Capital Projects Fund from \$0 to \$809,830.
- 7. Decrease the appropriation for "Public Works Administration Capital Purchases" expenditures in the Capital Projects Fund from \$1,133,000 to \$1,128,104.
 - 8. Increase the appropriation for "Public Works Administration Streets and Sidewalks Repairs" expenditures in the Capital Projects Fund from \$1,000,000 to \$1,004,896.

SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that this Ordinance shall become effective at the expiration of twenty (20) calendars days following adoption.
