Business Improvement Tax Credit. BE IT ENACTED BY THE COUNCIL OF THE CITY OF SECTION 1. ABERDEEN that § 482-12.A. Business Improvement Tax Credit will read as follows: A. The purpose of this section is to provide for a credit against City of Aberdeen real property taxes to the owner of any renovated or rehabilitated business property located within the City of Aberdeen where the property's assessed value increases as a result of the renovation or rehabilitation of the property AND SUBJECT TO THE OWNER OF ANY QUALIFYING BUSINESS REAL PROPERTY WHO MAKES A MINIMUM CAPITAL INVESTMENT OF \$50,000. SECTION 2. AND BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN that this Ordinance shall become effective at the expiration of twenty (20) calendar days following adoption.
