Designation of Real Property in Business Incentive 1 Subclass. SECTION 1. BE IT ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN that § 482-18 Designation of Real Property in Business Incentive 1 Subclass A. will read as follows: The Business Incentive 1 Subclass consists of improved real property located in A. the TOD Zoning District that meets one or more of the following criteria, MAKES A MINIMUM CAPITAL INVESTMENT OF \$25,000, and seeks inclusion in this subclass: SECTION 2. AND BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN that this Ordinance shall become effective at the expiration of twenty (20) calendar days following adoption.
