3 **AMENDMENT OF FY 2019 BUDGET**

4
5 **FOR** the purpose of amending the adopted budget for the City of Aberdeen for the fiscal year
6 beginning July 1, 2018, and ending June 30, 2019, to appropriate for certain purposes
7 certain funds from the City's unrestricted fund balances, and add additional revenue to
8 the General Fund and generally related to amendment of the City's FY 2019 budget.

12 **SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE**
13 **CITY OF ABERDEEN** that the "City of Aberdeen Budget Fiscal Year 2018-2019" adopted by
14 Ordinance No. 18-O-11 is amended as follows:

- 15 1. Increase the Planning and Community Development, Dept. No. 105, appropriation for
16 "Government Strategic Planning" from \$0 to \$70,000.
- 17 2. Increase General Fund "Appropriation of Fund Balance" Revenue No. 40998 from
18 \$1,387,285 to \$1,457,285.
- 19 3. Increase Total General Fund appropriation from \$17,676,081 to \$17,746,081.
- 20 4. Increase the Total Revenues General Fund from \$17,676,081 to \$17,746,081.

22 **SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND**
23 **COUNCIL OF THE CITY OF ABERDEEN** that the sums and amounts reflected in Section 1
24 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2018, and ending
25 June 30, 2019.

26 **SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND**
27 **COUNCIL OF THE CITY OF ABERDEEN** that this Ordinance shall become effective at the
28 expiration of twenty (20) calendars days following adoption.


