13 14 **SECTION 1. BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ABERDEEN** that Section VII.8 be of the Charter of the City of Aberdeen (as published by General Code Corporation), § VII, Elections and Board of Elections, is repealed and re-enacted, with amendments, to read as follows:

§ VII. Elections and Board of Elections.

- 8. Any candidate for the office of Council member or Mayor must file ((at least 35 days prior to and no earlier than 65 days prior to the date of the election)) a certificate of candidacy on a form provided by the Board. THE PERIOD TO FILE A CERTIFICATE OF CANDIDACY COMMENCES THE DAY AFTER LABOR DAY AND ENDS NINE BUSINESS DAYS LATER. THE CERTIFICATE OF CANDIDACY FORM MUST CONTAIN ((containing)) the following:
 - a. The applicant's mailing address and the address of the applicant's domicile.
 - **b.** The applicant's date of birth.
 - **c.** The dates and places of residence within the corporate limits of the City of Aberdeen by the applicant.
 - **d.** The certificate of candidacy shall be signed by the candidate under penalties of perjury and shall be accompanied by a nonrefundable filing fee of \$25 payable to City of Aberdeen.
 - **e.** A candidate who has filed may withdraw his or her certificate of candidacy after filing by delivering to the Aberdeen Board of Elections, at least 30 days prior to the date of the election, written notification of withdrawal signed by the candidate.
 - **f.** Each candidate shall complete the financial disclosure form as required by Chapter **43** of the Aberdeen City Code. This financial disclosure form shall be considered a part of the certificate of candidacy and no candidate may be considered eligible for placement on the ballot until this disclosure form is timely and satisfactorily completed and approved by the Ethics Commission.

SECTION 2. AND BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF ABERDEEN that the date of adoption of this Resolution is March 11, 2019, and the amendment of the Charter of the City of Aberdeen hereby enacted shall become effective on April 30, 2019, unless a proper petition for referendum hereon shall be filed as permitted by law, provided a complete and exact copy of this Resolution shall be continuously posted on the bulletin board in Aberdeen City Hall until April 20, 2019, and provided further that a copy of the title of this Resolution shall be published in The Record, a newspaper of general circulation in the City of Aberdeen, or in any other newspaper of such general circulation, once in each of the weeks beginning March 15, March 22, March 29, and April 5, 2019.

SECTION 3. AND BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF ABERDEEN that the City Clerk is hereby specifically commanded to carry out the provisions of Section 2, hereof, and, as evidence of such compliance, the City Clerk shall cause to be maintained appropriate certificates of publication of the newspaper or newspapers in which the title of the Resolution shall have been published. If a favorable referendum is held on the

Charter change, the Mayor shall proclaim the Charter change hereby enacted to have been approved by the voters and the charter amendment shall become effective on the date provided by law.

SECTION 4. AND BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF ABERDEEN that as soon as the Charter Amendment hereby enacted shall become effective, either as provided herein or following a referendum, the City Clerk shall send by mail to the Department of Legislative Services of Maryland, a clear certified copy of this Resolution showing the number of Councilpersons voting for and against it and a report on the votes cast for or against the amendment hereby enacted at any referendum thereon and the date of such referendum.

 The above Charter Amendment was enacted by the foregoing Resolution which was passed at a regular meeting of the Council of the City of Aberdeen on March 11, 2019, 6 members of the Council voting in the affirmative, 0 members of the Council voting in the negative, 0 members of the Council abstaining, and 0 members of the Council absent, and the said Resolution becomes effective accordance with the law on the thirtieth day of April, 2019
