3 **AMENDMENT OF FY 2019 BUDGET (8) Emergency**

5 FOR the purpose of amending the adopted budget for the City of Aberdeen for the fiscal year
6 beginning July 1, 2018, and ending June 30, 2019, to appropriate for certain purposes
7 certain funds from the City's unrestricted fund balances, and add additional revenue to
8 the General Fund and generally related to amendment of the City's FY 2019 budget.

12 **SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE**
13 **CITY OF ABERDEEN** that the "City of Aberdeen Budget Fiscal Year 2018-2019" adopted by
14 Ordinance No. 18-O-11 and amended is further amended as follows:

- 15 1. Increase the Government Buildings Dept. No. 106, appropriation for "Municipal
16 Buildings" from \$244,766 to \$269,766.
- 17 2. Increase General Fund "State Grants" Revenue No. 40315 from \$0 to \$25,000.
- 18 3. Increase Total General Fund appropriation from \$18,673,919 to \$18,698,919.
- 19 4. Increase the Total Revenues General Fund from \$18,673,919 to \$18,698,919.


21 **SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND**
22 **COUNCIL OF THE CITY OF ABERDEEN** that the sums and amounts reflected in Section 1
23 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2018 and ending
24 June 30, 2019.

28 effective on the day following its adoption by Council.




