AN ORDINANCE concerning

AMENDMENT OF FY 2020 BUDGET (2)

FOR the purpose of amending the adopted budget for the City of Aberdeen for the fiscal year beginning July 1, 2019, and ending June 30, 2020, to appropriate for certain purposes certain funds from the City's unrestricted fund balances and add additional revenue to the General Fund and generally related to amendment of the City's FY 2020 budget.

SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that the "City of Aberdeen Budget Fiscal Year 2019-2020" adopted by Ordinance No. 19-O-07 and amended, is further amended as follows:

1. Increase the Government Buildings Dept. No. 106, appropriation for "Capital Purchases" from \$1,000 to \$1,183,800.
2. Increase the General Government Dept. No. 107, appropriation for "Community Promotions" from \$30,000 to \$37,500.
3. Increase General Fund "Appropriation of Fund Balance" Revenue No. 40998 from \$1,576,985 to \$2,759,785.
4. Increase General Fund "County Grants" Revenue No. 40323 from \$0 to \$7,500.
5. Increase Total General Fund appropriation from \$17,991,166 to \$19,181,466.
6. Increase Total Revenues General Fund from \$17,991,166 to \$19,181,466.

SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that the sums and amounts reflected in Section 1 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2019 and ending June 30, 2020.

SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that this Ordinance shall become effective at the expiration of twenty (20) calendars days following adoption.
