RESOLUTION NO. 19-R-05

**A RESOLUTION OF THE CITY OF ABERDEEN
FOR THE PURPOSE OF SUPPORTING THE
NATIONAL ENDOWMENT FOR THE ARTS: OUR TOWN APPLICATION**

1 Resolution of the City of Aberdeen has approved the application and receipt of financing for the
2 National Endowment for the Arts: Aberdeen Main Street Strategic Planning and Design Services
3 (the “Project”) further described in the Our Town Application dated August 13, 2019 (the
4 “Application”), to be financed either directly by the National Endowment for the Arts (the
5 “Agency”), or through other departments or agencies of the United States.

7 **WHEREAS**, the City of Aberdeen recognizes that there is a significant need for reinvestment
8 and revitalization in the Main Street Area and
9

10 **WHEREAS**, the Agency, either through Our Town or through other programs of the Agency, or
11 in cooperation with other Federal departments or agencies, may provide half of the financing for
12 the Project (the “Project Financing”) in order to assist in making it financially feasible; and
13

14 **WHEREAS**, the applicable law and regulations require approval of the Project and the Project
15 Financing by the City of Aberdeen and, where appropriate, by the chief elected executive official
16 of the local subdivision;

18 **NOW, THEREFORE BE IT RESOLVED THAT**, the City of Aberdeen hereby endorses the
19 Project; and, **HEREBY** approves the request for financial assistance in the form of a grant, up to
20 the amount of \$50,000; and

22 **BE IT FURTHER RESOLVED THAT**, the chief elected executive official be, and is hereby
23 requested to endorse this Resolution, thereby indicating his approval thereof; and


1 **BE IT FURTHER RESOLVED THAT**, the Mayor is hereby authorized to execute documents
2 and take any action necessary to carry out the intent of this resolution; and

4 **BE IT FURTHER RESOLVED THAT**, copies of this Resolution are sent to the

8 **ABERDEEN** that this Resolution shall take effect from the date of its adoption.


