AN ORDINANCE concerning

MOBILE HOME AUTOMATIC FIRE SPRINKLER SYSTEMS

FOR the purpose of repealing a requirement that mobile homes be equipped with interior automatic fire sprinkler systems.

BY repealing and reenacting, with amendments
Chapter 269. Fire Prevention
Section 269-7.B.
Code of the City of Aberdeen (2010 Edition as amended)

SECTION 1. BE IT ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN, that Section 269-7.B. of Chapter 269, Fire Prevention, of the Code of the City of Aberdeen (2010 Edition as amended), is repealed and reenacted, with amendments, to read as follows:

Chapter 269 Fire Prevention

§ 269-7. Interior automatic fire sprinkler systems in new one- and two-family residential construction.

B. ((For the purposes of this article, mobile and modular homes will be exempt from the requirements to install interior automatic fire sprinkler systems until March 31, 2008. After this date, mobile and modular)) MODULAR homes IN THE CITY OF ABERDEEN ((will be required to have)) MUST BE EQUIPPED WITH interior automatic fire sprinkler systems((added)).

1 **SECTION 2. AND BE IT FURTHER ENACTED BY THE COUNCIL OF**
2 **THE CITY OF ABERDEEN** that this Ordinance shall become effective at the expiration
3 of twenty (20) calendar days following adoption.
