NOW, THEREFORE, BE IT RESOLVED, by the Mayor and City Council, that the property known as 727 OLD PHILADELPHIA ROAD, ABERDEEN, MARYLAND 21001, receive a real property tax credit against City taxes anticipated to begin for the Fiscal Year 2019/20 and continuing for nine (9) consecutive years thereafter; and BE IT FURTHER RESOLVED that the amount of the tax credit shall be equal to a percentage of the amount of the property tax imposed on the eligible assessment of the qualified property as follows:
