AN ORDINANCE concerning

AMENDMENT OF FY 2020 BUDGET (6)

FOR the purpose of amending the adopted budget for the City of Aberdeen for the fiscal year beginning July 1, 2019, and ending June 30, 2020, to appropriate for certain purposes certain funds from the City's unrestricted fund balances and add additional revenue to the General Fund and generally related to amendment of the City's FY 2020 budget.

SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that the "City of Aberdeen Budget Fiscal Year 2019-2020" adopted by Ordinance No. 19-O-07 and amended, is further amended as follows:

1. Increase the Transfers Dept. No. 800, appropriation for "Transfer to Ripken Stadium Fund" from \$807,767 to \$947,767.
2. Increase the Public Works Street Dept. No. 121, appropriation for "Motor Vehicle Expense" from \$60,000 to \$115,000.
3. Increase the Solid Waste Dept. No. 124, appropriation for "Motor Vehicle Expense" from \$25,000 to \$90,000.
4. Increase General Fund "Appropriation of Fund Balance" Revenue No. 40998 from \$2,904,322 to \$3,164,322.
5. Increase Total General Fund appropriation from \$19,681,089 to \$19,941,089.
6. Increase Total Revenues General Fund from \$19,681,089 to \$19,941,089.

1 **SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND**
2 **COUNCIL OF THE CITY OF ABERDEEN** that the sums and amounts reflected in Section 1
3 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2019 and ending
4 June 30, 2020.

6 **SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND**
7 **COUNCIL OF THE CITY OF ABERDEEN** that this Ordinance shall become effective at the
8 expiration of twenty (20) calendars days following adoption.
