**AN ORDINANCE concerning**

**TAXICABS, VEHICLES AND TRAFFIC, FEES**

**FOR** the purpose of revising regulations regarding vehicles and traffic; repealing certain provisions relating to taxicabs; and altering the amounts of certain fees in the City of Aberdeen.

**SECTION 1. BE IT ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN**, that Chapter 486 Taxicabs, of the Code of the City of Aberdeen (2010 Edition as amended), is repealed.

**SECTION 2. BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN**, that Section 505-10.A. of the Code of the City of Aberdeen (2010 Edition as amended), Chapter 505 VEHICLES AND TRAFFIC, is repealed and reenacted with amendments to read as follows:

Chapter 505. VEHICLES AND TRAFFIC

§ 505-10 Citations; violations and penalties.

- A. Upon violation of any of the provisions of this chapter, the Police Department is hereby authorized to issue citations for violations thereof, which shall be subject to the following fines and penalties:

**SECTION 3. BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN**, that Section A550-1.F. of Chapter A550 of the Code of the City of Aberdeen (2010 Edition as amended), is repealed and reenacted, with amendments, to read as follows:

Chapter A550. FEES

§ A550-1 Schedule of rates and charges.

The following fees, rates and charges shall apply in the City:



11 days following adoption.


