AN ORDINANCE concerning

AMENDMENT OF FY 2021 BUDGET (1)

FOR the purpose of amending the adopted budget for the City of Aberdeen for the fiscal year beginning July 1, 2020, and ending June 30, 2021, to appropriate for certain purposes certain funds from the City's unrestricted fund balances and add additional revenue to the General Fund and generally related to amendment of the City's FY 2021 budget.

SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that the "City of Aberdeen Budget Fiscal Year 2020-2021" adopted by Ordinance No. 20-O-07 is amended as follows:

~~1. Increase the Parks and Recreation Dept. No. 180, appropriation for "Parks and Recreation Committee" from \$0 to \$25,000.~~

~~2~~ 1. Increase the Municipal Separate Storm Sewer System Dept. No. 126, appropriation for "Operating Expenses" from \$100,000 to \$327,052.

~~3~~ 2. Increase the Police Dept. No. 110, appropriation for "Seized Funds – Dept. of Justice" from \$0 to \$14,000.

~~4-3.~~ Increase General Fund "Municipal Separate Storm Sewer System" Revenue No. 40327 from \$0 to \$227,052.

~~5~~ 4. Increase General Fund "Appropriation of Fund Balance" Revenue No. 40998 from \$669,308 to \$708,308.

~~6-5.~~ Increase Total General Fund appropriation from \$17,042,451 to \$ ~~17,308,503~~ 17,283,503.

~~7~~ 6. Increase Total Revenues General Fund from \$17,042,451 to \$ ~~17,308,503~~ 17,283,503.

1 **SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND**
2 **COUNCIL OF THE CITY OF ABERDEEN** that the sums and amounts reflected in Section 1
3 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2020 and ending
4 June 30, 2021.


