**AN ORDINANCE concerning**

**AMENDMENT OF FY 2021 BUDGET (3)**

FOR the purpose of amending the adopted budget for the City of Aberdeen for the fiscal year beginning July 1, 2020, and ending June 30, 2021, to appropriate for certain purposes certain funds from the City's unrestricted fund balances and add additional revenue to the General Fund and generally related to amendment of the City's FY 2021 budget.

**SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN** that the "City of Aberdeen Budget Fiscal Year 2020-2021" adopted by Ordinance No. 20-O-07 and amended, is further amended as follows:

1. Increase the Executive Dept. No. 101, appropriation for "Operating Expenditures" from \$32,355 to \$51,555.
2. Increase the Planning and Community Development Dept. No. 105, appropriation for "Operating Expenditures" from \$88,271 to \$109,188.
3. Increase the Public Works Streets Dept. No. 121, appropriation for "Motor Vehicle Expense" from \$80,000 to \$130,000.
4. Increase General Fund "Appropriation of Fund Balance" Revenue No. 40998 from \$683,308 to \$752,508.
5. Increase General Fund "State Grants" Revenue No. 40315 from \$187,615 to \$208,532.
6. Increase Total General Fund appropriation from \$17,646,019 to \$17,736,136.


7. Increase Total Revenues General Fund from \$17,646,019 to \$17,736,136.

**SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN** that the sums and amounts reflected in Section 1 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2020 and ending June 30, 2021.

**SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN** that this Ordinance shall become effective at the expiration of twenty (20) calendars days following adoption.
