AN ORDINANCE concerning

OVERNIGHT PARKING AND STANDING PROHIBITION

FOR the purpose of prohibiting the parking and standing of vehicles on City-owned parking lots during certain hours; providing a fine and other means of enforcement for violations; and generally relating to certain prohibited standing and parking of vehicles in the City of Aberdeen.

SECTION 1. BE IT ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN that Section 505-7.F. is hereby added to Chapter 505, Vehicles and Traffic, Code of the City of Aberdeen (2010 Edition as amended), to follow immediately after Section 505-E. and to read as follows:

Chapter 505
Vehicles and Traffic

§505-7 **Additional Parking Regulations**

F. **STANDING AND PARKING ON CITY-OWNED PARKING LOTS.**

- (1) A PERSON MAY NOT PARK OR STAND A VEHICLE, OR LEAVE A VEHICLE PARKED OR STANDING, ON A CITY-OWNED PARKING LOT BETWEEN THE HOURS OF 11:00 P.M. AND 5:00 A.M., SEVEN DAYS A WEEK.
- (2) A VEHICLE LEFT PARKED OR STANDING ON A CITY-OWNED PARKING LOT IN VIOLATION OF PARAGRAPH (1), AND IN WHICH SIGNAGE HAS BEEN ERECTED AS REQUIRED BY PARAGRAPH (3), IS SUBJECT TO IMPOUNDMENT AT THE VIOLATOR'S EXPENSE AND A FINE AS SPECIFIED IN SECTION 505-10.A.
- (3) THE CITY DEPARTMENT OF PUBLIC WORKS SHALL ERECT SIGNAGE AT THE ENTRANCE TO AND IN ONE OR MORE OTHER PROMINENT LOCATIONS IN EACH CITY-OWNED PARKING LOT, GIVING NOTICE (I) OF THE PROHIBITION SET FORTH IN PARAGRAPH (1), (II) THAT VEHICLES PARKED OR STANDING ON A CITY-OWNED PARKING LOT IN VIOLATION OF PARAGRAPH (1) ARE SUBJECT TO A FINE OF \$40 AND IMPOUNDMENT AT THE VIOLATOR'S EXPENSE, AND (III) THE ADDRESS AND TELEPHONE NUMBER OF THE STORAGE FACILITY TO WHICH IMPOUNDED VEHICLES WILL BE REMOVED.

SECTION 2. BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN that Chapter 505, Vehicles and Traffic, Section 505-10.A., Code of the City of Aberdeen (2010 Edition as amended), is repealed and reenacted, with amendments to read as follows:

Chapter 505
Vehicles and Traffic

§ 505-10 Citations; violations and penalties.

Upon violation of any of the provisions of this chapter, the Police Department is hereby authorized to issue citations for violations thereof, which shall be subject to the following fines and penalties:

SECTION 3. AND BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN that this Ordinance shall become effective at the expiration of twenty (20) calendar days following adoption.
