BE IT FURTHER ENACTED BY THE COUNCIL OF THE City of Aberdeen (2010 Edition as amended), is repealed and reenact amendments to read as follows: Chapter 505 Vehicles and Traffic § 505-10 Citations; violations and penalties. Upon violation of any of the provisions of this chapter, the Police Department i authorized to issue citations for violations thereof, which shall be subject to the fines and penalties: Code Provision Fine *** § 505-7E, Parking unregistered vehicle § 505-7F, STANDING AND PARKING ON CITY-OWNED PARKING LOTS § 505-8A, Endangering the health/safety of cat/dog
