AN ORDINANCE concerning

AMENDMENT OF FY 2022 BUDGET (1)

FOR the purpose of amending the adopted budget for the City of Aberdeen for the fiscal year beginning July 1, 2021, and ending June 30, 2022, to appropriate for certain purposes certain funds from the City's unrestricted fund balances and add additional revenue to the General Fund and generally related to amendment of the City's FY 2022 budget.


SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that the "City of Aberdeen Budget Fiscal Year 2021-2022" adopted by Ordinance No. 21-O-07 is amended as follows:

1. Increase the Transfers Dept. No. 800, appropriation for "Transfer to Water Fund" from \$0 to \$126,000 for Transit Oriented Development (TOD) capital connection fee credit for 34 N. Philadelphia Blvd, and 15 S. Rogers St.
2. Increase the Transfers Dept. No. 800, appropriation for "Transfer to Sewer Fund" from \$0 to \$64,800 for Transit Oriented Development (TOD) capital connection fee credit for 34 N. Philadelphia Blvd, and 15 S. Rogers St.
3. Increase General Fund "Appropriation of Fund Balance" Revenue No. 40998 from \$1,162,238 to \$1,353,038.
4. Increase Total General Fund appropriation from \$18,170,433 to \$18,361,233.
5. Increase Total Revenues General Fund from \$18,170,433 to \$18,361,233.


1 **SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND**
2 **COUNCIL OF THE CITY OF ABERDEEN** that the sums and amounts reflected in Section 1
3 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2021 and ending
4 June 30, 2022.

6 **SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND**
7 **COUNCIL OF THE CITY OF ABERDEEN** that this Ordinance shall become effective at the
8 expiration of twenty (20) calendars days following adoption.




