3 **AMENDMENT OF FY 2023 BUDGET (3)**  
4

5 FOR the purpose of amending the adopted budget for the City of Aberdeen for the fiscal year  
6 beginning July 1, 2022, and ending June 30, 2023, to appropriate for certain purposes  
7 certain funds from the City's unrestricted fund balances and add additional revenue to the  
8 General Fund and Capital Projects Fund and generally related to amendment of the City's  
9 FY 2023 budget.

13 **SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE**  
14 **CITY OF ABERDEEN** that the "City of Aberdeen Budget Fiscal Year 2022-2023" adopted by  
15 Ordinance No. 22-O-06 and amended, is further amended as follows:

- 16 1. Increase the Government Building Dept. No. 106, appropriation for "Capital  
17 Purchases" from \$42,993 to \$74,993.
- 18 2. Increase the Police Dept. No. 110, appropriation for "Community Policing" from  
19 \$16,050 to \$114,125.
- 20 3. Increase the Planning and Community Development Dept. No. 105 appropriation for  
21 "Main Street Program" from \$43,829 to \$78,829.
- 22 4. Increase General Fund "State Grants" Revenue No. 40315 from \$0 to \$133,075.
- 23 5. Increase General Fund "Appropriation of Fund Balance" from \$1,807,143 to  
24 \$1,839,143.
- 25 6. Increase the appropriation for "Community Development Block Grant Projects"  
26 expenditures in the Capital Projects Fund from \$445,362 to \$663,959.

1           7. Increase Capital Projects Fund “Block Grant” Revenue No. 40313 from \$445,362 to  
2           \$663,959.

3           8. Increase Total General Fund appropriation from \$19,305,618 to \$19,470,693.

4           9. Increase Total Revenues General Fund from \$19,305,618 to \$19,470,693.





5           10. Increase Total Capital Projects Fund appropriation from \$3,941,594 to \$4,160,191.

6           11. Increase Total Revenues Capital Projects Fund from \$3,941,594 to \$4,160,191.

8           **SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND**  
9           **COUNCIL OF THE CITY OF ABERDEEN** that the sums and amounts reflected in Section 1  
10          of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2022 and ending  
11          June 30, 2023.

13          **SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND**  
14          **COUNCIL OF THE CITY OF ABERDEEN** that this Ordinance shall become effective at the  
15          expiration of twenty (20) calendars days following adoption.
