AN ORDINANCE concerning

WATER TANK SITE PROPERTY ACQUISITION AUTHORIZATION Emergency

FOR the purpose of approving the acquisition, for no monetary consideration, of a 14,196 square feet (0.326 acres)+/-, parcel of land in the vicinity of Technology Drive and MD Route 22, owned by Maryland Transportation Authority, as a site for the construction of a west side water tank; and matters generally related to the acquisition of a site for the erection of a water tank for the City of Aberdeen.

EXPLANATORY STATEMENT: The Maryland Transportation Authority ("MDTA") owns the 14,196 square feet (0.326 acres)+/-, parcel of land in the vicinity of Technology Drive and MD Route 22 as described in the Quit Claim Deed attached hereto as Exhibit 1 ("Parcel 1-A"). The City has determined that Parcel 1-A would be a suitable and appropriate location for the construction of a water tank to serve properties on the west side of Aberdeen. MDTA is willing to convey Parcel 1-A to the City for no monetary consideration by the attached Quit Claim Deed. The Mayor and Council believe that the City's acquisition of Parcel 1-A from MDTA is in the long-term interests of the City and its residents. Now, therefore,

SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that the acquisition of the Parcel from MDTA for no monetary consideration, pursuant to the attached Quit Claim Deed, as a site for the construction of a water tank is in the interests of the City of Aberdeen and is hereby authorized; and the Mayor is hereby authorized to execute the Quit Claim Deed and any other usual and customary documents to effectuate the conveyance and acceptance of the Parcel.

SECTION 2. BE IT FURTHER ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF ABERDEEN that this Ordinance shall become effective on the day following its adoption by the Council.

WHEREAS, MDTA has prepared, or caused to be prepared Right of Way Plat designated as State Highway Administration Plat numbered 62108 (the "Plat"), which plat has been or is intended to be filed for record with and electronically recorded by the Maryland State Archives; all of which plat is made a part hereof, and which is duly recorded, or intended to be recorded among the Land Records of the aforesaid County being a portion of the parcel of land identified as Harford County Tax Number 02-060167 and all of the parcel of land identified as Harford County Tax Number 02-056321.

WHEREAS, under the provisions of Section 10-305 of the State Finance and Procurement Article of the Annotated Code of Maryland, it is necessary for the Board of Public Works of Maryland to join in this conveyance.

WHEREAS, transferors certify under penalties of perjury that the transferors are resident entities of the State and that no tax is due under Tax-General, § 10-912(c).

BEING a part of the same property conveyed by a deed dated May 17, 1989 and recorded among the Land Records of Harford County in CGH Liber 1468 Folio 356 from Leonard McGrady to MDTA. BEING all of the same property conveyed by a deed dated February 7, 2000 and recorded among the Land Records of Harford County in CGH Liber 3201 Folio 133 from Alvah H. Johnson Jr. to MDTA.

NOW, THEREFORE, THIS DEED WITNESSETH: That for and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the said parties of the first and second parts do hereby quit claim unto the CITY OF ABERDEEN, A MUNICIPAL CORPORATION OF THE STATE OF MARYLAND, all that property designated as Parcel 1-A (containing 0.326 acres, more or less) on the reduced copy of the aforesaid Plat which is attached hereto and incorporated herein as Exhibit No. 1.

Subject to an agreement between the City of Aberdeen and MARYLAND TRANSPORTATION AUTHORITY (MDTA) named the Water and Sanitary Sewer Facilities Ownership Agreement dated June 25, 2001, attached hereto and incorporated herein as Exhibit No. 2, which agreement is merged into this deed and of no further force or effect.

TOGETHER with the buildings and improvements thereon, and the rights, roads, ways, waters, privileges and appurtenances thereunto belonging or in anywise appertaining, but SUBJECT TO encumbrances, easements, and restrictions of record.

SUBJECT, HOWEVER, TO EACH AND EVERY RESERVATION, RESTRICTION, CONDITION, COVENANT, AND CONTROL SET FORTH IN THIS INSTRUMENT OF WRITING.

The conveyance of the herein described property is not based on any monetary consideration but is a transfer between two governmental entities.
