	SECTION 1. BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE CITY BERDEEN that the "City of Aberdeen Budget Fiscal Year 2023-2024" adopted by nce No. 23-O-07 and amended, is further amended as follows:	
	1. Increase the Finance Dept. No. 103 appropriation for "Capital Purchases" from \$1,000 to \$16,660.	
	2. Increase the Planning and Community Development Dept. No. 105 appropriation for "Community Legacy Projects" from \$78,743 to \$178,743.	
	3. Increase the Government Building Dept. No. 106, appropriation for "Capital Projects" from \$618,422 to \$623,222.	
	4. Increase the Police Dept. No. 110, appropriation for "Community Policing" from \$110,300 to \$427,809.	
	5. Increase the Police Dept. No. 110, appropriation for "Overtime" from \$153,010 to \$272,010.	
	6. Increase the Miscellaneous Dept. No. 162, appropriation for "Opioid Prevention & Abatement" from \$0 to \$5,225.

- 7. Increase the Transfers Dept. No. 800, appropriation for "Transfer to Stadium Fund" from \$358,500 to \$403,500.
  - 8. Increase General Fund "State Grants" Revenue No. 40315 from \$590,850 to \$1,008,359.
  - 9. Increase General Fund "Opioid Litigation Settlement" Revenue No. 40328 from \$0 to \$5,225.
    - 10. Increase General Fund "Appropriation of Fund Balance" from \$4,749,898 to \$4,934,358.
      - 11. Increase Total General Fund appropriation from \$24,007,627 to \$24,614,821.
      - 12. Increase Total Revenues General Fund from \$24,007,627 to \$24,614,821.
