





Dear Councilman Garner:

The Aberdeen Board of Elections met on Wednesday, November 14 to review the submitted reports of financial contributions and expenditures. Your report was not approved based on your disbursement on Schedule No. 2 in the amount of \$250.00 cash to Bayside Home Ltd., which is not a recognized 501C-3 and, of which, you are the owner. The Board believes that your intent was good because you wrote that the donation was for the setup of a mod office for Harford Family House; however, the disbursement does not adhere to the directives of the Code as indicated below.

§36-5 B. Disposition of surplus funds. Prior to the time of filing the final report required by this section, any surplus funds remaining after payment of all campaign expenditures shall be:

(1) Paid to the local Board of Education or to a recognized nonprofit organization providing services or funds for the benefit of pupils or teachers.

(2) Paid to a local charitable or civic organization deemed to be a 501C-3 corporation as established by the United States Internal Revenue Service.

Please provide the Board documentation that this is a valid contribution to a 501C-3 and, in addition, you will also need to submit an amended report indicating that the funds have been dispersed in the proper manner according to the §36-5B(1)(2). Please contact me if you have any questions.
