BE IT ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN, that new Section 422-1 is hereby added to the Code of the City of Aberdeen (2010 Edition as amended), to be under new Chapter 422, PROHIBITED OCCUPANCIES, to follow immediately after Chapter 417, PEDDLING AND SOLICITING, and to read as follows:

1 **CHAPTER 422. PROHIBITED OCCUPANCIES** 2 3 § 422-1. USE AND OCCUPANCY PROHIBITION. 4 5 A PERSON MAY NOT USE OR OCCUPY, FOR PURPOSES OF HUMAN A. 6 HABITATION FOR MORE THAN 24 CONSECUTIVE HOURS AT THE SAME 7 LOCATION: 8 9 (1) A TENT; 10 11 (2) ANOTHER TYPE OF TEMPORARY OR PORTABLE SHELTER; OR 12 13 A TEMPORARY STRUCTURE THAT IS NOT A DWELLING UNIT AS (3) 14 DEFINED IN THE CITY OF ABERDEEN DEVELOPMENT CODE. 15 FOR PURPOSES OF THIS SECTION, "LOCATION" MEANS A LOT OR PARCEL 16 B. 17 OF LAND AS SHOWN ON A SUBDIVISION PLAT OR TAX MAP OR AS 18 DESCRIBED BY DEED. 19 20 C. THIS SECTION SHALL BE ENFORCED BY SWORN LAW ENFORCEMENT OFFICERS AND CODE ENFORCEMENT OFFICERS OF THE CITY OF 21 22 ABERDEEN POLICE DEPARTMENT. 23 24 D. UPON OBSERVING A PERSON WHO IS VIOLATING SUBSECTION A. OF THIS 25 SECTION, A SWORN LAW ENFORCEMENT OFFICER OR A CODE 26 ENFORCEMENT OFFICER SHALL HAND DELIVER TO THE PERSON WRITTEN 27 NOTICE THAT DIRECTS THE PERSON TO CEASE THE VIOLATION AND 28 ADVISES THE PERSON OF CORRECTIVE MEASURES NECESSARY TO CURE 29 THE VIOLATION. 30 31 E. A PERSON WHO FAILS OR REFUSES TO CEASE A VIOLATION OF THIS 32 SECTION AFTER NOTICE IN ACCORDANCE WITH SUBSECTION D. IS GUILTY 33 OF A MUNICIPAL INFRACTION AND IS LIABLE FOR A FINE IN THE AMOUNT 34 OF \$50 FOR EACH VIOLATION. EACH DAY THAT A VIOLATION CONTINUES 35 IS A SEPARATE OFFENSE. 36 37 SECTION 2. BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY 38 **OF ABERDEEN,** that this Ordinance shall become effective at the expiration of twenty (20) 39 calendar days following adoption.
