SECTION 1. BE IT ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN, that new Section 47-1 is hereby added to the Code of the City of Aberdeen (2010 Edition as amended), to be under new Chapter 47, FUNDING OF ABERDEEN VOLUNTEER FIRE DEPARTMENT, INC., to follow immediately after Chapter 43, ETHICS, and to read as follows:

CHAPTER 47. FUNDING OF ABERDEEN VOLUNTEER FIRE DEPARTMENT

§ 47-1. GRANT TO ABERDEEN VOLUNTEER FIRE DEPARTMENT, INC.

A. COMMENCING WITH THE CITY'S 2018 FISCAL YEAR, THE CITY OF ABERDEEN ANNUALLY SHALL PROVIDE GRANT FUNDING TO THE ABERDEEN VOLUNTEER FIRE DEPARTMENT, INC., AS PROVIDED IN THIS SECTION.

B. THE GRANT FUNDING REQUIRED BY THIS SECTION MAY BE MADE SUBJECT TO A GRANT AGREEMENT BETWEEN THE CITY OF ABERDEEN AND THE ABERDEEN VOLUNTEER FIRE DEPARTMENT, INC. THE GRANT AGREEMENT MAY PROVIDE FOR THE DISTRIBUTION AND USE OF THE GRANT FUNDS AND ANY OTHER TERMS AND CONDITIONS RELATING TO THE USE OF THE GRANT FUNDS AND THE OPERATION OF THE FIRE DEPARTMENT AS THE CITY MAY REQUIRE.

C. EACH YEAR THE CITY'S OPERATING BUDGET SHALL INCLUDE AN APPROPRIATION FOR THE ANNUAL GRANT TO THE ABERDEEN VOLUNTEER FIRE DEPARTMENT, INC. THE APPROPRIATION SHALL BE AN AMOUNT EQUAL TO THE REVENUE GENERATED BY THE CITY PROPERTY TAX LEVIED ON ALL TAXABLE REAL PROPERTY IN THE CITY IN AN AMOUNT OF \$.02 FOR EACH \$100 OF ASSESSED VALUATION OF TAXABLE REAL PROPERTY, BUT IN NO EVENT SHALL THE AMOUNT OF THE ANNUAL APPROPRIATION AND GRANT BE LESS THAN \$260,000 OR MORE THAN \$300,000 500,000.

SECTION 2. BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY OF ABERDEEN, that this Ordinance shall become effective at the expiration of twenty (20) calendar days following adoption.
