RESOLUTION NO. 17-R-05

**A RESOLUTION OF THE CITY OF ABERDEEN FOR THE PURPOSE OF
SUPPORTING THE COMMUNITY LEGACY APPLICATION (2)**

1 Resolution of the City of Aberdeen is approving the application and receipt of financing for a
2 Community Legacy Project (the "Project") further described in the Community Legacy
3 Application (the "Application"), to be financed either directly by the Department of Housing and
4 Community Development of the State of Maryland (the "Department"), or through other
5 departments or agencies of the State of Maryland.

7 **WHEREAS**, the City of Aberdeen recognizes that there is a significant need for reinvestment
8 and revitalization of the communities in Harford County/Aberdeen; and

9
10 **WHEREAS**, the Department, either through Community Legacy or through other programs of
11 the Department, or in cooperation with other State departments or agencies, may provide some or
12 all of the financing for the Project (the "Project Financing") in order to assist in making it
13 financially feasible; and

15 **WHEREAS**, the Project, located within a designated priority funding area under Section 5-7B-
16 02 of the Smart Growth Act, is located in a Sustainable Community, as identified in the
17 Sustainable Communities Act of 2010, and the Project will conform to the local zoning code; and

18
19 **WHEREAS**, the applicable law and regulations require approval of the Community Legacy
20 Project and the Project Financing by the City of Aberdeen and, where appropriate, by the chief
21 elected executive official of the local subdivision.


1 **NOW, THEREFORE BE IT RESOLVED THAT** the City of Aberdeen hereby endorses the
2 Project; and hereby approves the request for financial assistance in the form of a grant or loan, up
3 to the amount of \$300,000; and

5 **BE IT FURTHER RESOLVED THAT** the Mayor and City of Aberdeen is hereby authorized
6 to execute documents and take any action necessary to carry out the intent of these resolutions;


9 **BE IT FURTHER RESOLVED THAT** copies of this Resolution be sent to the Secretary of


12 **BE IT FURTHER RESOLVED THAT** this Resolution shall take effect from the date of its
