Mayor Bennett called the meeting to order at 7:00 p.m. in the Council Chambers. The prayer was led by Chaplain Major Steven Simpson, from Aberdeen Proving Ground and the Pledge of Allegiance was led by Councilwoman Young.

A motion was made by Councilwoman Elliott and seconded by Councilman Garner to approve the minutes of the August 8, 2011 meeting as submitted.

The following statement of closed session was read by the City Clerk.

Statement of Closed Session:

"On August 8, 2011, the Mayor and Council held a regularly scheduled Council Meeting in Council Chambers which began at 7:00 p.m. All members voted by roll call in the affirmative to close the session.

At approximately 7:47 p.m. a closed session was convened by the Mayor and Council in the second floor administrative conference room. Members present were: Mayor Michael E. Bennett, Councilwoman Elliott, Councilman Bruce Garner, Councilwoman Sandra Landbeck, and Councilwoman Ruth Ann Young. Also in attendance were Douglas Miller, City Manager, and Monica Correll, City Clerk.

The session was held pursuant to the Open Meetings Act, Section 10-508(a): (1)(i) The appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of appointees, employees, or officials

over whom it has jurisdiction; and, (14) before a contract is awarded or bids are opened, discuss a matter directly related to a negotiation strategy or the contents of a bid or proposal, if public discussion or disclosure would adversely impact the ability of the public body to participate in the competitive bidding or proposal process.

During this meeting, the Mayor and Council discussed with the City Manager the formulation of the Annexation Agreement for Aberdeen Technology Campus, LLC & Route 22 Properties. The Mayor and Council also discussed the repeal of Aberdeen Board and Committee Code Sections and gave instruction that ordinances be drafted for introduction. No other action was taken.

The meeting was adjourned at 8:21 p.m."

PRESENTATIONS:

1. Daughters of the American Revolution, 9/11 Flag

Councilwoman Young introduced Ms. Betty Myers, Vice-Regent of the Harbor of Grace Chapter of the National Society of the Daughters of the American Revolution. Both Councilwoman Young and Vice-Regent Myers presented a flag to the Mayor, City Council, and Aberdeen citizens in remembrance of the September 11, 2001 tragedy.

PUBLIC HEARINGS:

1. Ordinance No. 11-O-10. Refinancing CDA Loans

Mr. Miller proceeded to explain that the City introduced this ordinance on August 8, 2011 to refinance the five loans taken out through the Maryland Department of Housing and Community Development infrastructure loan program (CDA) for expenses at Ripken Stadium, City Hall, and the Public Works Shop. Ordinance No. 11-O-10 allows the City to borrow up to ten million dollars to replace the existing debt resulting in significant savings on interest costs. There are two methods of refinancing; private placement through banks and private sale. The City will also proceed to acquire a bond rating.

Also present were Mr. Steve Winter, Bond Counsel, and Mr. Samuel Ketterman, financial consultant, who answered questions from the Council. Mr. Ketterman said that after a rating committee visits the City, a decision should be rendered in early October. He further explained that even if the Ordinance is passed, the City is not required to sell the bonds if the savings level is unacceptable. The rating lasts throughout the life of the transaction but does not mean that the rating is firm since rating agencies are supposed to perform annual reviews.

a) Ms. Karen Heavey, W. Bel Air Avenue;Ms. Heavey expressed support of the Ordinance and expressed her concerns.

The Council questioned interest rate stability to which Mr. Ketterman answered that interest rates are set once the bids are accepted.

The Swim Center Advisory Committee has not been active for at least five years and there is no need for this committee. The Boys & Girls Club has taken over the management and operation of the pool.
