

**City of Aberdeen Council Meeting  
March 14, 2011**

Mayor Bennett called the meeting to order at 7:00 p.m. in the Council Chambers. The prayer was led by Pastor Kenneth Telsee of True Joy Ministries and the Pledge of Allegiance was led by Councilwoman Elliott.

1. Proclamation for American Diabetes Week, Sharon Sheppe

Mayor Bennett presented a proclamation to Ms. Sharon Sheppe of M & T Bank to increase diabetes awareness. March 22-26, 2011 was proclaimed as American Diabetes Week in the City of Aberdeen. Ms. Sheppe made comments and announced upcoming events relative to diabetes.

2. Proclamation for the Boys & Girls Clubs of Harford County

3. Presentation - Clean Energy Grant, Kate Autry, Grant Coordinator

Ms. Kate Autry announced that the City of Aberdeen was awarded \$40,000 from Maryland State Energy for the Clean Energy Grant Program to provide 5-7 eligible families, low-to-moderate incomes, with energy upgrades to their homes. She encouraged interested parties to contact the City.

Mr. Faircloth announced the next Aberdeen Communities Together (ACT) meeting. He also stated his opposition to the tax breaks requested by Presbyterian Home. He said that local Harford County delegates should represent the desires of the citizens and encouraged citizens to contact them. He supported the Council in their efforts to obtain the hotel tax and prevent unfair tax forgiveness.

The Council discussion included the Heritage Trust lecture series, the grand opening of Perryman Station Senior Apartments, the Aberdeen High School Girls Basketball Team, Christian Slattery (Hall's Cross Roads Elementary School teacher) as a candidate for Harford County Teacher of the Year, and the citizen response to the Presbyterian Home project along with House Bill (HB) 584. The Council encouraged participation in the Clean Energy Grant Program and expressed satisfaction with the outcome of the Comprehensive Plan under the direction of Ms. Grover.

2. Business from the Mayor

The Mayor stated that the hearing on HB 584 is scheduled for March 17, 2011 and that he and the Council will be united against tax exemption for the independent living units of the Village at Carsins Run (Presbyterian Home). They are also united in favor of the hotel tax. He urged the citizens to attend the Council Meetings and asked for their feedback.
