#### Synopsis of Events:

Officer Buettner's AXON camera, issued by the Aberdeen Police Department, was activated during this incident. VEHICLE IN MOTION (PHASE 1) On 05/05/2024 at approximately 0538 hours this Officer was dispatched to 231 N. Philadelphia Blvd., Aberdeen, Maryland, 21001, the Wawa for an individual who is believed to be sleeping at gas pump number four.

The reporting party, manager on duty advised the Aberdeen Police Department (APD) Dispatch that the individual within the vehicle had been at the pump for approximately twenty minutes without moving from the pump. Upon this Officer's arrival on the scene, this Officer observed a vehicle bearing Maryland registration of the pump, with the vehicle lights being on, at rest to the right of pump number four. Officer observed a white male sitting in the operator's seat of the vehicle. The suspect was impaired.

While looking through the rear passenger seat windows of the vehicle, the Officer viewed and identified a handgun lying on the floorboard, directly behind the operator's seat of the vehicle. Immediately upon this observation, this Officer placed the suspect under detainment at 0552 hours and was placed in this Officer's patrol vehicle. The officer then recovered the firearm within the vehicle at 0552 hours. The firearm was a Sig Sauer P938 9mm handgun. Also, recovered were four baggies with an unknown white powder, suspected CDS Fentanyl/Heroin, one pack of Buprenorphine and naloxone 8mg/2mg, one pack of prepackaged cannabis. The subject was arrested.

#### Synopsis of Events:

Officers responded to 343 Carter St. 4 separate times today in reference to issues with the COA trash cans.
