BID NO. 19-01

STREET RESURFACING AND REPAIR, CITY OF ABERDEEN, MARYLAND

To all holders of the specifications, the following corrections are hereby made. All other items shall remain unchanged.

The following are answers to questions posed by bidders:

Q1: What is the budgeted amount to be spent for FY19?

A1: The budget amount for the FY19 Street Resurfacing project is \$1,000,000.

Q2: Why aren't the quantities on the manholes and water vales per street listed on the bid form? It the bid supposed be incidental work requirements?

A2: The cost of any manhole and valve adjustments should be incidental to the paving.

Q3: Are liquidating damages capped at \$300 per day as per Section 4.1 of the General Provisions?

A3: Liquidating damages are capped at \$300 per day for any contract price over \$500,000.

Q4: The specifications call for 1.5" surface depth, as stated in section 4.3.1. of the Special Provisions. The bid form lists 2" surface depth. Is 2" the correct depth? **A4:** The 2" depth is the correct depth.

Q5: Why is the last sentence included in Section 4.2.1. of the Special Provisions? Section 4.2.1. of the Special Provisions states:

"...This item does not apply to milling operations necessary to complete Item 501 or 503." A5: The following sentence shall be **removed** from section 4.2.1. of the Special Provisions: "This item does not apply to milling operations necessary to complete Item 501 or 503."

Q6: Section 4.1.1.2 of the Special Provisions states that the contractor will get paid up to 5% increase on required asphalt, but is the increase 5% or 15%?

A6: Section 4.1.1.2 of the Special Provisions allows for an adjustment in unit price for hot mix asphalt to account for an increase in asphalt binder if the asphalt binder cost fluctuates above 15% since this contract is for one year and the estimated mix quantity is less than 10,000 tons.

Q7: For the CR6 Stone specified in the bid form, will the contractor get paid for 1000 tons of stone or is this line item considered incidental work?

A7: The undercut and refill will be considered incidental to the unit cost of the CR6 item.

Q8: Should driveways be included as a separate item on the bid form? In case driveways or sidewalks need to be replaced?

A8: Any transition required between the back of the curb and existing sidewalk or driveway will use the concrete sidewalk line item listed on the bid form.

Q9: Is there a list of street names?

A9: The list of street names and pictures are attached to this Addendum as Appendix No. 2

Q10: Adjustment of existing utilities: if the project is milling and replacing 2" of HMA, theoretically the grade does not change, therefore do we assume that all utilities that are acceptable (and functioning properly in the case of the drainage inlets) prior to construction activities, and are not damaged by construction activities, will not be adjusted? **A10:** It is an acceptable assumption that all utilities will not need to be adjusted for milling.

Q11: What is the criteria for price increases (in addition to asphalt cement) for option years 2 and 3? There are many costs other than the asphalt cement (e.g. :labor, fuel, equipment and subcontractors) that could increase substantially during a 3 year period. **A11:** There are no other price adjustments proposed.

Q12: What does it mean in Special Provision Section 1.1.4. "Incident to the contract, milling wider than two feet (2') shall be at the expense of the contractor"? **A12:** The following sentence shall be **removed** from the Special Provision Section 1.1.4. "Incident to the contract, milling wider than two feet (2') shall be at the expense of the contractor."

Q13: What is item 505 CR-6 stone base used for?

A13: This item will be used as needed to provide fill under and in front of any replacement curb and under any replacement sidewalk.

Q14: Is the project milling "taper" mill for transitions along the curbs and at the project limits or is the milling "full mill" over the entire roadway, edge to edge? **A14:** The milling is intended to be full width milling of roads prior to resurfacing.

Q15: Do you have a record available of the quantities paid to the contractor (not prices necessarily) on this contract in prior years?

A15: Attached as Appendix No. 1 is a worksheet of the quantities from last fiscal year. This was a \$500,000 contract year.

Q16: What is item 501A - 2" Bituminous base used for?

A16: For the front of curb replacement or in areas where the City of Aberdeen wants to thicken sections of the road beyond the 2" surface layer.










