#### LANDSCAPE MAINTENANCE

#### **GENERAL PROVISIONS**

#### 1. SCOPE OF WORK

- 1.1. The landscape contractor shall provide all materials, labor, and equipment required to complete all landscape maintenance work as specified in the contract
- 1.2. It is recommended that the landscape contractor have Landscape Industry Certified Technicians–Exterior on staff and performing the work whenever possible
- 1.3. The landscape contractor shall be familiar with the project premises and how the existing conditions will affect his/her work.

#### 2. STANDARDS

- 2.1. All landscape maintenance services shall be performed by trained personnel using current and acceptable horticultural practices. All employees on site must be properly licensed in accordance with the State of Maryland statute.
- 2.2. All operators of power equipment shall conform to Occupational Safety and Health Administration (OSHA) regulations. Contractor shall prepare and make available on site, a Health and Safety Plan (HASP). HASP shall conform to current OSHA and State regulations.
- 2.3. All work shall be performed in a manner that maintains the original integrity of the landscape design.
- 2.4. Visibility: The Contractor is providing an extension of services that the City provides therefore: the contractor will present a high degree of professionalism, consistent deliverables, to exceed the agreed upon services.
- 2.5. Contractors shall submit a proposed landscaping schedule on how they intend to meet the requirements of this contract. The Work Performance Plan must specify how often the contractor is expected to perform the work covered in each Exhibit based on a typical growth season in Maryland. (i.e. once per week, twice per month, etc.)

- 2.5.1. A work performance plan must be submitted within 30 calendar days of award to the City for each contract year.
- 2.5.2. Work shall be performed to minimize disruption to owners, tenants, and operations of aforementioned. Contractor shall schedule work efforts to have the least impact on homeowners and businesses in the project areas.
- 2.5.3. Work shall be done within public areas Monday through Friday from 7:00 am to 7:00 pm; Weekends 8:00 am to 5:00 pm.
- 2.5.4. Work Scheduling: The City reserves the right to alter and/or re-schedule work during periods when continuous concurrent events occur at the site that hinder the completion of the ground's maintenance work required by the contract.
- 2.6. All chemical applications shall be performed in accordance with current county, state, and federal laws, utilizing EPA registered materials and methods of application. These applications shall be performed under the supervision of a state of Maryland licensed and certified pesticide applicator.
- 2.7. Contractor shall submit to the City of Aberdeen all applicable and current licenses required. Licenses shall be kept current for the duration of project.
- 2.8. Contractor is required to follow State Highway approved Temporary Traffic Control Measures identified in the Books of Standards published from the State Highway Administration when working alongside or within any Right of Way.
  - 2.8.1. Flaggers are required to meet American Traffic Safety Services Association (ATSSA) Flagger Training Course.
  - 2.8.2. The contractor shall maintain and provide copies of SHA certifications to work on all State roadways in accordance with all applicable regulations.
  - 2.8.3. All traffic control costs are expected to be minimal and therefore will be integrated within the overall cost of the contract. No separate line items for traffic control will be provided on the bid forms.
- 3. PESTICIDE, HERBICIDE, AND FERTILIZER APPLICATIONS
  - 3.1. The contractor is required to comply with the Maryland's Department of Agriculture (MDA) regulations for the transport and application of pesticides, herbicides, and fertilizers under this contract. This includes but is not limited to all licensees and certifications, training of staff, permits, notifications, specified equipment, and application procedures to use the products to meet the specified areas in this contract. The contractor is directed to the MDA website: <a href="http://mda.maryland.gov">http://mda.maryland.gov</a> for further guidance.

- 3.2. The contractor is required to have on site a (Material Safety Data Sheet) MSDS, Safety Plan, and Spill Prevention Plan for all chemicals used to prevent harm to the contractor's staff and the protection of the environment. This information must be available at all times and be produced when using the applications on site within the contract.
- 3.3. The contractor is required to provide their staff with all training and personal protection equipment determined by the chemical in use. The contractor will also have any safety wash stations i.e. hand and eye wash, first aid kit, etc.

#### 4. WARRANTY

4.1. The contractor shall make every effort to maintain the health and growth of all plant material and turf. The landscape contractor shall not be responsible to guarantee the viability of the plant material or turf, except when that landscape contractor was obviously negligent in the performance of his/her work as outlined in the contract.

#### 5. INSURANCE REQUIREMENTS

- 5.1. Certificate of Insurance: Before starting work on the contract, the contractor shall provide the City of Aberdeen with an original Certificate(s) of Insurance from the contractor's insurance provider.
- 5.2. Contractor's Responsibility: The providing of any insurance herein does not relieve the contractor of any of the responsibilities or obligations the contractor has assumed in the contract or for which the contractor may be liable by law or otherwise.
- 5.3. Failure to Provide Insurance: Failure to provide and maintain the required insurance shall be deemed a material breach of the contract.
  - 5.3.1. Insurance Coverage (as described below)
  - 5.3.2. Comprehensive General Liability Insurance
- 5.4. Limits of Coverage
  - 5.4.1. Bodily Injury Liability: \$1,000,000 each occurrence; and \$3,000,000 aggregate products and completed operations.
  - 5.4.2. Property Damage Liability: \$1,000,000 each occurrence; and \$3,000,000 aggregate for those coverages subject to an aggregate limit.
- 5.5. Liability Protection: Such insurance shall protect the contractor from claims which may arise out of, or result from, the contractor's operations under the

contract, whether such operations be by the contractor, any subcontractor, anyone directly or indirectly employed by the contractor or subcontractor, or anyone for whose acts of the above may be liable.

- 5.5.1. Coverage to be included:
  - 5.5.1.1. Independent contractor's coverage;
  - 5.5.1.2. Completed operations and products liability
  - 5.5.1.3. Coverage; and
  - 5.5.1.4. Contractual liability coverage
- 5.5.2. Damages not to be excluded:
  - 5.5.2.1. Such insurance shall contain no exclusions applying to operations by the contractor or any subcontractor in the performance of the contract pertaining to: 1) Collapse of, or structural injury to, any building or structure; 2) Damage to underground property; or 3) Damage arising out of the landscaping operations.
- 5.6. Comprehensive Automobile Liability Insurance: General Coverage such insurance shall provide coverage for all owned, non-owned and hired automobiles.
  - 5.6.1. Limits Bodily Injury Liability: \$ 500,000 @ person; and \$1,000,000 @ occurrence
  - 5.6.2. Property Damage Liability: \$ 500,000 @ person; and \$1,000,000 @ occurrence
- 5.7. Workers Compensation Insurance: Such insurance must contain statutory coverage, including Employers' Liability, with a limit of at least \$100,000.

#### 5.8. HOLD HARMLESS CLAUSE:

- 5.8.1. Indemnification from Claims, Liability, Expense, etc.: The contractor shall indemnify the City of Aberdeen and hold it harmless against any and all claims, suits, liability, expense or damage (either alleged or actual) in connection with this contract and anything done thereunder.
- 5.8.2. Indemnification from Injury, Death or Damage Liability: The contractor shall protect, hold free and harmless, defend and indemnify the City of Aberdeen (including its officers, agents and employees) free from all liability, penalties, costs, losses, damages, expenses, causes of action, claims or

judgments (including attorneys' fees) resulting from injury to, or death of, any person, or damage to property of any kind, which injury, death or damage to property of any kind, which injury, death or damage arises out of, or is in any way connected with, the performance of the work under this contract.

- 5.8.3. Application of Exception: Aforesaid hold harmless and indemnity agreement shall apply to any acts or omissions, willful misconduct or negligent conduct, whether active or passive, including acts or omissions of contractor's agents or employees; except that said agreement shall not be applicable to injury, death or damage to property arising solely from the negligence or willful misconduct of the City's officers, agents, and employees.
- 6. PROPERTY LOST, DAMAGE OR DESTROYED: Any property or work to be provided by contractor will remain at the contractor's risk until written acceptance by the City of Aberdeen; and the contractor will replace, at the contractor's expense, all property or work lost, damaged or destroyed by any cause whatsoever.
- 7. BASIS FOR BID:
  - 7.1. Contractor shall enter fixed fee price on the Bid Form.
  - 7.2. Payment shall be made on the basis of the completion of the work detailed in the project specifications. All invoices shall be submitted for payment within fourteen (14) calendar days after the 30<sup>th</sup> day of each month of services completed for Exhibit A, B, C, and D and within fourteen (14) calendar days upon completion of work specified in Exhibit E. Payment shall be made by the City within thirty (30) calendar days of receipt of invoice and final acceptance of the work by the City of Aberdeen. The City has the right to dispute any invoices within ten (10) calendar days of receipt of invoice.
  - 7.3. Upon Award and prior to signing of the contract, the contractor must designate payment for Exhibit A, B, C, and D either as either
    - 7.3.1. Bid amount paid over eight (8) equal months corresponding to the growing season work for work commencing between April 1 to November 30 for each contact year, or
    - 7.3.2. Bid amount amortized over twelve (12) equal payments corresponding with annual contract. Contactor must remain in compliance with all provisions of the contract during to receive amortized payment on a monthly basis.
  - 7.4. In either case, the actual amount invoices shall not exceed the total bid specified using either paragraph 7.3.1 or 7.3.2 for payment of Exhibits A, B, C, and D.

Once the contractor designates method of payment the City will place stipulations in the contract (CA-1 to CA-3).

- 7.5. Payment for Exhibit E shall be based on a time and material-based estimate at the time that work is identified for each site. The Contractor shall establish a contracted rate per hour per individual which includes all material and equipment rates per standard contracted rate. This contracted rate shall be provided in the bid form and will be the basis for payment to the contractor. No additional mobilization costs shall be incurred for each site.
- 8. BASIS FOR AWARD:
  - 8.1. The City reserves the right to reject any and all Bids, to waive any and all informalities and to negotiate contract terms with the Successful Bidder, and the right to disregard all nonconforming, non-responsive or conditional Bids. Discrepancies between words and figures will be resolved in favor of words. Discrepancies between the indicated sum of any column of figures and the correct sum thereof will be resolved in favor of the correct sum.
  - 8.2. In evaluating Bids, the City shall consider the qualifications of the Bidders, whether or not the Bids comply with the prescribed requirements, and alternates and unit prices if requested in the Bid forms. It is the City's intent to accept alternates (if any are accepted) in the order in which they are listed in the Bid form but the City may accept them in any order or combination.
  - 8.3. The City may consider the qualifications and experience of Subcontractors and other persons and organizations (including those who are to furnish the principal items of material or equipment) proposed for those portions of the Work as to which the identity of Subcontractors and other persons and organizations must be submitted as provided in the Supplementary Conditions. Operating cost, maintenance considerations, performance data and guarantees of materials and equipment may also be considered by the City.
  - 8.4. The City may conduct such investigations, as it deems necessary to assist in the evaluation of any Bid and to establish the responsibility, qualifications and financial ability of the Bidders, proposed subcontractors and other persons and organizations to do the work in accordance with the Contract Documents to the City's satisfaction within the prescribed time.
  - 8.5. The City reserves the right to reject the bid of any bidder who does not pass any such evaluation to the City's satisfaction.
  - 8.6. If the contract is to be awarded, it will be awarded to the lowest Bidder whose evaluation by the City indicates to the City that the award will be in the best interests of the project.

8.7. If the contract is to be awarded, the City will give the Successful Bidder a Notice of Award within sixty (60) calendar days after the day of the bid opening.

## 9. TERMS

- 9.1.1. The terms of this contract is annual subject to the approval of funds authorized in the City Budget by July 1 for each fiscal year with the ability for the City to renew with the contactor for two (2) additional contract years at one (1) year increments.
- 9.1.2. Each successful option year executed by the City will allow for an up to a ten (10) percent increase of costs based on the monthly/unit rate. If exercised, an Economic Price Adjustment Modification request must be submitted to the Procurement Office within sixty (60) days of contract end date.

#### **10. TERMINATION CLAUSE**

10.1. This agreement may be terminated by either party by giving thirty (30) days written notice by certified mailed, return receipt requested, addressed to the other party at the address listed on the bid form.

#### 11. BID BOND

11.1. No bid bond will be required.

#### LANDSCAPE MAINTENANCE

#### SPECIAL PROVISIONS

#### 1. General

- 1.1. Proper landscape maintenance sustains the quality and health of a landscaped area and preserves the intended design concept. Landscaping is intended to provide overall aesthetically pleasing appearance for the community.
- 1.2. The items within this section describe required specifications in the maintenance of the areas under this contract. The contractor shall comply with all special provisions with further guidance provided in each exhibit specified within the contract.
- 1.3. The growing season is from April 1 to November 30 for each Calendar Year. Any work shall not be done during the non-growing season from December 1 to March 31 for each year under contact. An aggressive growth cut back shall be done within the last two weeks prior to end of each growing season to ensure vegetation enter a dormant state during the non-growth season. The contractor is expected to adjust schedules, materials or labor to meet the requirements as dictated by weather conditions during the growing season to comply with all aspects of this contract.
- 1.4. Exceptions to these provisions for the purposes of Additional Land Requests outlined in Exhibit D or Code Enforcement area outlined in Exhibit E.

#### 2. Turf

- 2.1. Mowing and Cleanup
  - 2.1.1. Prior to each mowing, all trash, sticks, and other unwanted debris shall be removed from lawns and all areas to be mowed to avoid any flying debris. Such debris shall be removed from the site entirely rather than blown into the road or piled off to the side.
  - 2.1.2. Mowing height for grass shall occur between 2.5 inches to 3 inches in height. All areas shall be mowed according to the rate of grass growth throughout the growing season. Only 1/3 of the blade should be removed at any single cutting. Grass height shall NOT exceed five (5) inches at any time during the growing season.

- 2.1.3. Mowing operation shall include trimming around all obstacles, removing excess grass clippings, and removing debris from walks, curbs, and parking areas.
- 2.1.4. Mowing patterns shall alternate between cuttings to avoid creating ruts and compaction.
- 2.2. Edging
- 2.2.1. Edging of all sidewalks, curbs and other paved areas shall be performed. All seams and cracks in sidewalks and curbs shall be kept weed free through chemical/manual control.
- 2.2.2. Edging shall be performed with a blade type mechanical edger. The cut edge should appear as a clean, straight line.
- 2.2.3. A monofilament line trimmer shall be used to trim around obstacles within the lawn area. Care shall be taken to ensure the bark of trees and shrubs are not damaged or stripped by the line trimmer.
- 2.2.4. The Contractor shall make a visual observation of the area to ensure the areas is clear of items that could be damaged by debris. Debris from the edging operations shall be removed and the areas swept or blown clean.
- 3. Pruning
  - 3.1. Pruning of bushes and shrubs is included in the scope of this contract.
  - 3.2. Pruning of trees is not included in the scope of this contract.
- 4. Pesticide, Herbicides & Fertilization
  - 4.1. The contractor shall comply with all aspects of the Maryland Department of Agriculture to include but not limited to reporting, application rate for pesticides, herbicides, and fertilizations applications, public notifications, spills, and any other requirements. <u>http://mda.maryland.gov</u>
  - 4.2. The contractor shall be responsible for monitoring the landscape sites on a regular basis. The Contractor shall use trained personnel to monitor plant damaging insect activity, plant pathogenic diseases, and potential cultural problems in the landscape. The pest or cultural problem will be identified under the supervision of the contractor. If any invasive species are found, take immediate action to remove.

- 4.3. All turf and mulch beds shall be weeded (mechanical/manual) and/or chemically treated on a continual basis throughout the growing season to maintain a neat appearance.
- 5. Mulching:
  - 5.1. Plant beds shall receive a general cleanup before mulching. Cleanup includes:
    - 5.1.1. Cutting back herbaceous perennials left standing through winter (e.g., ornamental grasses, Sedum Autumn Joy). Established beds may require dividing and thinning.
    - 5.1.2. Thoroughly weed area by manually removing all weeds, chemically treating all weeds, or a combination of the two.
    - 5.1.3. Cultivate existing mulch and/or remove excess soil and/or mulch to expose the root flare and so that when new mulch is applied, there is no more than a total depth of 2" of mulch.
    - 5.1.4. Edge previously mulched beds to create a 90-degree edge with a depth of 2" to 3" and remove resulting debris. Single tree plantings in turf shall have the trunk of the tree located in the center of the mulched area (tree ring).
  - 5.2. Mulch shall be limited to a maximum total depth no greater than 2" and applied only where the existing mulch has been either cultivated into the soil or removed. Special care shall be taken in the mulching operation not to over mulch or cover the base of trees and shrubs
  - 5.3. Only composted hardwood bark mulch, pure pine bark mulch, composted mix pine bark mulch, or unscreened compost shall be used in beds containing shallow rooted woody species, herbaceous perennials, or annuals. Mulch shall be "Brown dyed."
- 6. Debris Removal:
  - 6.1. Litter and trash including leaves, rubbish, paper, bottles, cans, rocks, gravel, and other debris shall be removed entirely from all areas on a weekly basis.
  - 6.2. All trash shall be removed from all shrub and ground cover beds and removed from site entirely.
  - 6.3. All trash shall be removed from turf areas prior to mowing and removed from site entirely.

- 6.4. All refuse resulting from the cleanup and maintenance operation of the City's properties shall be disposed of properly by the contractor to an authorized landfill.
- 6.5. Hardscape (i.e. sidewalks, patios, driveways, roadways) shall be swept or blown free of debris immediately upon completion of work and away from any storm drains.
- 7. Leaf Removal:
  - 7.1. Fallen leaves shall be mulched or removed from maintained areas on a contractual basis.
  - 7.2. If requested by the City, supplemental leaf removals shall be performed by the landscape contractor at an additional cost to the City.
- 8. Special Access Requirements
  - 8.1. Contractor shall be required to access certain secured facilities to perform duties within the scope of this contract.
  - 8.2. The contractor shall provide a lock and key that will be properly daisy chained together with other locks at each site during the growing season of the contractor's performance period.
    - 8.2.1. City personnel can demonstrate proper connection of locks to Contractor or its representative if necessary.
    - 8.2.2. Keys or combination to Contractor provided locks shall be provided to City to provide access to sites in the event the are daisy chained improperly.
    - 8.2.3. Locks will be removed during non-growing seasons.
  - 8.3. Only authorized personnel performing work in accordance with the contract will be allowed in these areas.
  - 8.4. The contractor shall be responsible to properly secure areas when departing.

- 1. Work within this exhibit shall generally consist of the following locations described below and covered under the general and special provisions of the specifications: Mowing and Cleanup, Edging, Herbicides, and Debris Removal
- 2. The Contractor shall address each requested area described below:
  - 2.1. Work performed for each line item will be completed by the contractor at the request of the City. Contractor shall base work efforts to address each line item as a separate requirement.
    - 2.1.1. Para 2 Line Item 001 to 005 will have up to six (6) requests per cutting season.
    - 2.1.2. Para 2 Line Item 006 to 007 will have up to four (4) request per cutting season.
  - 2.2. The contactor shall taper cuts between sections below to provide a natural visual flow. Shoulders Cutting for the purpose of this Exhibit shall be measured from the edge of the road on both sides to:
    - 2.2.1. where no sidewalk exists: edge of road to approximately six (6) feet.
    - 2.2.2. where sidewalk exist: edge of road to two (2) feet beyond sidewalk.
    - 2.2.3. where guard rail exist: edge of road to two (2) feet beyond guard rail.
    - 2.2.4. where conflict occurs i.e. presence of a sidewalk with guard rail, the contractor shall cut from the roadway plus two (2) feet beyond the obstruction.

## CODE ENFORCEMENT SUPPORT

- 1. This work shall be performed under the direction of the Code Enforcement Officer anytime during each calendar year under contract.
- 2. Work within this exhibit shall consist of the following items covered under the general and special provisions of the specifications: Mowing, Cleanup, Edging, and Debris Removal (related directly to ensure safe mowing operations only). Contractor shall not be responsible for debris removal of large items (sofas, couches, household trash, etc.). Contractor shall work around all household items to the best of their staff's ability.
- 3. This exhibit shall be based on a time and material-based estimate at the time that work is identified for each site. The Contractor shall establish a contracted rate per hour per individual which includes all equipment rates. This contracted rate shall be provided in the bid form and will be the basis for payment to the contractor. No additional mobilization costs shall be incurred for each site.
- 4. The City shall, under the direction of the Code Enforcement Officer,
  - a. Provide site address where work will be performed.
  - b. Provide brief scope of work (mowing, edging, pruning, etc.) required
- 5. The Contractor shall
  - a. Provide a written cost estimate for number of hours and individuals required for proposed work based on the approved contracted rate within two (2) business days of notice.
  - b. Upon approval by the Code Enforcement officer, the Contractor shall proceed with all work identified in the City's scope within five (5) business days.
  - c. The contractor shall invoice, separately, for each site completed within fourteen (14) calendar days upon completion of work. Each invoice shall include the following

- i. Site Location
- ii. Date work was performed
- iii. Number of individuals required based on approved estimate.
- iv. Number of hours of service based on approved estimate.
- v. Invoice Amount shall correspond to approved estimate using.
  - 1. # Individuals required multiplied by # work hours multiplied by approved contracted rate.
- d. If conflict or potential issue arises for service between the contractor and the owner/renter of the property, the contractor shall immediately contact the City's code enforcement officer for clarification.
