Pre-Bid Meeting Minutes

- 1. We reviewed the project generally comprises of installation of approximately 350 linear feet of 8" water mains, installation of a meter vault, and restoration to paved, seeded and other areas disturbed by construction operations.
- 2. Reminded all attendees that bids will be received at City Hall until 2:00 PM prevailing time on Thursday, October 7, 2021.
- 3. Informed the attendees questions on the bid document will be accepted until 4:00 PM prevailing time on Thursday, September 30, 2021.
- 4. Directed all technical questions shall be directed, by e-mail, to John Hart at John.Hart@arroconsulting.com at the office of the Engineer.
- 5. Reminder that all bid must be accompanied by bid security in the form of a bid bond, certified check or bank check for 5% of the bid total.
- 6. Reviewed the contract times; Substantial Completion Friday, March 25, 2022, Final Completion April 1, 2022. There are Liquidated Damages set at \$500.00 a calendar day.
- 7. Noted the bid form is a lump sum cost with two-unit price contingency items, miscellaneous excavation and backfill.
- 8. Reminded everyone that working hours are 7:00 AM to 5:00 PM. Any request to deviate from this will need to be made in writing for review by the City.
- 9. Informed them the selected contractor will need to submit shop drawings to ARRO for their review and approval.
- 10. Informed everyone the selected contractor will need to coordinate work with the City's Public Works Department. Shutdowns will need to be scheduled a minimum of 2 weeks prior to the scheduled shutdown.
- 11. Noted there is an E & S Plan that has been submitted, reviewed and approved by Harford County. This plan will need to be followed throughout this project.

- 12. Reminder that the selected contractor will need to create "red-line as-constructed" drawings and submit them to them to the City for their review and approval.
- 13. Informed attendees that all testing (compaction, deflection, bacteria, pressure, etc.) is to be performed by the selected contractor and included in the bid.

Discussion notes:

- 14. The City is open to waiting for fair and reasonable material delays if necessary but this will need to be approved by the City.
- 15. All communications shall go through ARRO.
- 16. The meter detail is not a Harford County Standard Detail.
- 17. ARRO will provide survey data for construction stake-out.
- 18. Procurement forms are available on the City's website.
- 19. This project is <u>not</u> prevailing or Davis-Bacon wages.
