- b. Retreat Visions: The Novak Consulting Group under the direction of Catherine Tuck Parrish conducted a two-day retreat with the Council March 14 and 15, 2014. The following was a summary of the retreat discussions.

c. Comcast Franchise Agreement; Needs Assessment

Comcast requires a needs assessment in order to renew their franchise agreement with the City. A public hearing will be held.

d. Building Permit Assessment

For the last fiscal year, total building permits were up 15%; residential permits were up 21%; commercial permits were down in number but valuation was up; total construction value went up, both residential and commercial construction values were up as well. Most of the increase in residential was due to applications for solar panels on houses.

e. Ripken World Series Parade

The Mayor invited everyone to attend the Cal Ripken World Series Parade on August 9th at 10:00 a.m. in downtown Aberdeen. There will be eighteen teams from various states and countries who will be participating in the World Series held at Cal Sr.'s Yard. The Vi Ripken Field will be dedicated on August 11 at 3:00 p.m.

f. Aberdeen Proving Ground (APG) Water and Sewer Update

Mr. Miller updated the Council that the City owns and operates the water and sewer systems on APG. The water currently comes from Harford County or the Chapel Hill Water Treatment Plant. The goal of the Army is to decommission the Chapel Hill Plant and convert to using the Building 250 site (another water treatment plant). The City has provided a water tower to provide the storage necessary for the conversion. The City is also in the process of upgrading the APG plant to Enhanced Nutrient Technology (ENR). Withdrawal permits are being updated and public hearings will be held. The last project involves work on the wells, at Building 250, in order to make it operational.

g. APG/ Supplemental Programmatic Environmental Assessment (SPEA)

The City has been alerted by the Army Alliance, following the Army's published SPEA, about a potential realignment for a reduction in troop strength from 570,000 to 190,000 by the year 2020. In Maryland, this will affect Fort Meade and APG with a reduction of 4,300 positions at APG (1,000 military and 3,300 civilians). The Mayor said that this is viewed as a budgetary exercise and the Army Alliance advises us in order to properly plan.

Other Business

• The Mayor said he attended a promotional ceremony for Brigadier General Bruce T. Crawford who was promoted to Major General. General Dennis L. Via (4-star) presided over the ceremony which was attended by many dignitaries and guests.

- The Council discussed the properties in disrepair located on Route 22, near the City's entrance. The process to rectify the situation was underway.
- As a point of clarification, Councilwoman Young said that the City of Aberdeen was responsible for the water and sewer on APG North (Aberdeen area) and not on APG South (Edgewood area).
- The Phase II process has started on the Regional Water and Sewer Authority concept proposed by Harford County Executive David Craig. The Technical Advisory Group that supports the Advisory Committee in their deliberations is currently conducting meetings.
