- 1 (2) Whether the approved plan has been properly implemented and maintained;
- 2 (3) Practice deficiencies or erosion and sediment control plan deficiencies;
- 3 (4) If a violation exists, the type of enforcement action taken; and
- 4 (5) If applicable, a description of any modifications to the plan.

5 ((D))C. The inspection agency shall notify the on-site personnel or the owner/developer, in
6 writing, when violations are observed, describing:

- 7 (1) The nature of the violation;
- 8 (2) The required corrective action; and
- 9 (3) The time period in which to have the violation corrected.

11 **SECTION 3. BE IT FURTHER ENACTED BY THE COUNCIL OF THE CITY**
12 **OF ABERDEEN**, that this Ordinance shall become effective at the expiration of twenty (20)
13 calendar days following adoption.




