**RESOLUTION NO. 13-R-11**

**A RESOLUTION OF THE CITY OF ABERDEEN  
FOR THE PURPOSE OF SUPPORTING THE  
STRATEGIC DEMOLITION AND SMART GROWTH IMPACT FUND**

1 Resolution of the City of Aberdeen to approve the application (the “Application”) and  
2 financing for a Strategic Demolition and Smart Growth Impact Fund project in the City of  
3 Aberdeen, Maryland (the “Project”), to be funded by the Department of Housing and  
4 Community Development of the State of Maryland (the “Department”), or through other  
5 departments or agencies of the State of Maryland.

7 WHEREAS, the City of Aberdeen recognizes that there is a significant need for  
8 reinvestment and revitalization of the communities in Harford County/Aberdeen; and  
9

10 WHEREAS, the Department, through Strategic Demolition and Smart Growth Impact  
11 Fund or other programs of the Department, or in cooperation with other State departments or  
12 agencies, may provide some or all of the funding for the Project (the “Project Financing”) to  
13 make the Project financially feasible; and

15 WHEREAS, the Project (“Exhibit A”) is located within a designated priority funding area  
16 under Section 5-7B-02 of the Smart Growth Act, is located in a Sustainable Community, as  
17 identified in the Sustainable Communities Act of 2010, and the Project will conform to the  
18 Aberdeen Development Code; and

20 WHEREAS, the applicable law and regulations require approval of the Project and the  
21 Project Financing by the City of Aberdeen; and

23 NOW, THEREFORE BE IT RESOLVED THAT, the City of Aberdeen hereby endorses  
24 the Project; and HEREBY approves the request for financial assistance in the form of a grant or  
25 loan, up to the amount of \$485,000; and


26 BE IT FURTHER RESOLVED THAT, the following persons are hereby authorized to


32 BE IT FURTHER RESOLVED THAT, copies of this Resolution be sent to the Secretary




