**RESOLUTION NO. 14-R-07**

**A RESOLUTION OF THE CITY OF ABERDEEN  
FOR THE PURPOSE OF SUPPORTING AND ACKNOWLEDGING  
THE HARFORD FAMILY HOUSE PROJECT (THE "PROJECT")**

1 **WHEREAS**, Harford Family House, Inc., a nonprofit organization located at 53 East Bel Air  
2 Avenue in Aberdeen, Maryland, proposes to undertake the Project described below (the  
3 "Project"); and

5 **WHEREAS**, the primary purpose of this Project is to provide transitional housing and support  
6 services to homeless families with children utilizing the apartment building located at 53 East  
7 Bel Air Avenue in Aberdeen, Maryland as well as appropriate housing at other addresses in the  
8 surrounding community, helping these families transition to permanent, stable housing; and

10 **WHEREAS**, Harford Family House has applied to the Department of Housing and Community  
11 Development of the State of Maryland for approval of the Project and an allocation of tax credits  
12 for business entities that contribute to the Project, under the Department's Community  
13 Investment Tax Credit Program.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Mayor and City Council of the City of  
16 Aberdeen, hereby expresses support of the Project, as described above, and urge the Department  
17 of Housing and Community Development to grant approval under the Community Investment  
18 Tax Credit Program.

20 **BE IT FURTHER RESOLVED** that this Resolution shall take effect from the date of its  
21 adoption.


