ORDINANCE NO. 16-O-12 BUDGET FY 2016-2017

AN ORDINANCE CONCERNING THE CITY OF ABERDEEN FY 2016-2017 BUDGET FOR the purpose of adopting the City of Aberdeen FY 2016-2017 Budget; and all matters generally relating thereto.

SECTION 1: BE IT ENACTED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ABERDEEN THAT the Budget for the City of Aberdeen for fiscal year beginning 1 July 2016 and ending 30 June 2017, attached hereto as Attachment 1 and incorporated herein by reference, and entitled, "City of Aberdeen, Operating and Capital Budgets, Fiscal Year 2017 (July 1, 2016 – June 30, 2017)", is adopted and for all purposes shall be considered the FY 2016-2017 Budget for the City of Aberdeen. The Budget shall include revenue and expenditures for the Water Enterprise Fund, Sewer Enterprise Fund, Stadium Enterprise Fund, General Fund, and all Capital Budgets related thereto.

SECTION 2: BE IT FURTHER ENACTED THAT the FY 2017 General Fund Budget is based on an annual real property tax rate of \$0.6566 per \$100 of assessed value and an annual personal property tax rate of \$1.70 per \$100 of assessed value, both of which are levied and imposed by this Ordinance upon all properties within the City of Aberdeen that are subject to real and personal property taxation.

SECTION 3: BE IT FURTHER ENACTED THAT the FY 2017 Water Use Rate shall be a minimum charge of \$17.85 for the first 3,500 gallons or less and \$5.39 per each additional 1,000 gallons. The Sanitary Sewer Use Rate shall be a minimum charge of \$19.57 for the first 3,500 gallons or less of metered water and \$5.58 per each additional 1,000 gallons of metered water.

SECTION 4: AND BE IT FURTHER ENACTED THAT this Ordinance shall become effective on 1 July, 2016.
