RESOLUTION NO. 15-R-06

1 **A RESOLUTION** endorsing a loan in an amount of \$125,000 from the Maryland
2 Department of Business and Economic Development (the “Department”) to **Medline Industries,**
3 **Inc.**, or an entity acceptable to the Department (the “Loan”) pursuant to the Maryland Economic
4 Development Assistance Fund, Sections 5-301 through 5-349 of the Economic Development
5 Article of the Annotated Code of Maryland, to assist Medline Industries, Inc. with the following
6 “Project”: the expansion of its current distribution operations and renovations to the existing
7 facility located at **100 Rock Glenn Boulevard, Havre de Grace, Maryland** (the “Project Site”),
8 including installation of new equipment purchases and improvements; and authorizing a
9 workplace training grant in the amount of \$60,000 over a 3-year period from Harford County,
10 Maryland to assist Medline Industries, Inc. with employee training at the Project Site.

12 **WHEREAS**, the Mayor and City Council recognize the significant importance of
13 economic development in Aberdeen and Harford County and support various economic
14 development programs; and

16 **WHEREAS**, Medline Industries, Inc. anticipates retaining approximately 77 full-time
17 employees at the Project Site, while creating an additional 35 new positions, including Harford
18 County citizens at the Project Site; and

20 **WHEREAS**, the Mayor and City Council has determined that the Project is a priority
21 and seeks to endorse the Project and Loan.

23 **NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and City Council that
24 pursuant to Section 5-319(d) of the Economic Development Article of the Annotated Code of
25 Maryland, the City endorses the Project and the \$125,000 Loan from the Department to Medline
26 Industries, Inc.;



28 **BE IT FURTHER RESOLVED**, that the Mayor and City Council endorses the use of
29 Harford County funds for a workplace training grant in the amount of \$20,000 per year over a 3-
30 year period for a total not to exceed \$60,000 to be awarded to Medline Industries, Inc.

32 **AND BE IT FURTHER RESOLVED**, that this Resolution shall take effect from the
33 date of its adoption.


