**LOCAL RESOLUTION OF SUPPORT
FOR THE COMMUNITY LEGACY APPLICATION**

1 Resolution of the City of Aberdeen is approving the application and receipt of financing
2 for a Community Legacy Project (the "Project") further described in the Community Legacy
3 Application ("The Application"), to be financed either directly by the Department of Housing
4 and Community Development (the "Department") of the State of Maryland or through other
5 departments or agencies of the State of Maryland.

7 **WHEREAS**, the City of Aberdeen recognizes that there is a significant need for
8 reinvestment and revitalization of the communities in Harford County; and,

10 **WHEREAS**, the Department, either through Community Legacy or through other
11 Programs of the Department, or in cooperation with other State departments or agencies, may
12 provide some or all of the financing for the Project (the "Project Financing") in order to assist in
13 making it financially feasible; and

15 **WHEREAS**, the Project is located within a priority funding area under Section 5-7B-02
16 of the Smart Growth Act and the Project will conform to the local zoning code; and

18 **WHEREAS**, the applicable law and regulations require approval of the Community
19 Legacy Project and the Project Financing by the City of Aberdeen and, where appropriate, by the
20 chief elected executive official of the local subdivision.


22 **NOW, THEREFORE BE IT RESOLVED THAT**, the City of Aberdeen hereby
23 endorses the Project; and, hereby approves the request for financial assistance in the form of a
24 grant or loan, up to the amount of \$50,000; and

26 **BE IT FURTHER RESOLVED THAT**, the Mayor and City of Aberdeen is hereby
27 authorized to execute documents and take any action necessary to carry out the intent of these
28 resolutions; and

1 **BE IT FURTHER RESOLVED THAT**, copies of this Resolution are sent to the
2 Secretary of the Department of Housing and Community Development of the State of Maryland;

5 **BE IT FURTHER RESOLVED THAT** this Resolution shall take effect from the date
6 of its adoption.


