RESOLUTION NO. 16-R-09

**A RESOLUTION OF THE CITY OF ABERDEEN
FOR THE PURPOSE OF SUPPORTING THE
COMMUNITY LEGACY APPLICATION**

1 Resolution of the City of Aberdeen is approving the application and receipt of financing
2 for a Community Legacy Project (the "Project") further described in the Community Legacy
3 Application (the "Application"), to be financed either directly by the Department of Housing and
4 Community Development of the State of Maryland (the "Department"), or through other
5 departments or agencies of the State of Maryland.

7 **WHEREAS**, the City of Aberdeen recognizes that there is a significant need for
8 reinvestment and revitalization of the communities in Harford County/Aberdeen; and

9
10 **WHEREAS**, the Department, either through Community Legacy or through other
11 programs of the Department, or in cooperation with other State departments or agencies, may
12 provide some or all of the financing for the Project (the "Project Financing") in order to assist in
13 making it financially feasible; and

14
15 **WHEREAS**, the Project is located within a designated priority funding area under
16 Section 5-7B-02 of the Smart Growth Act, is located in a Sustainable Community, as identified
17 in the Sustainable Communities Act of 2010, and the Project will conform to the local zoning
18 code; and

20 **WHEREAS**, the applicable law and regulations require approval of the Community
21 Legacy Project and the Project Financing by the City of Aberdeen and, where appropriate, by the
22 chief elected executive official of the local subdivision.



24 **NOW, THEREFORE BE IT RESOLVED THAT**, the City of Aberdeen hereby
25 endorses the Project; and **HEREBY** approves the request for financial assistance in the form of a
26 grant or loan, up to the amount of \$100,000; and

1 **BE IT FURTHER RESOLVED THAT**, the Mayor and City of Aberdeen is hereby
2 authorized to execute documents and take any action necessary to carry out the intent of these
3 resolutions; and

5 **BE IT FURTHER RESOLVED THAT**, copies of this Resolution be sent to the
6 Secretary of Housing and Community Development of the State of Maryland.

8 **BE IT FURTHER ENACTED BY THE MAYOR AND COUNCIL OF THE CITY**
9 **OF ABERDEEN** that this Resolution shall take effect from the date of its adoption.




