## A RESOLUTION OF THE CITY OF ABERDEEN FOR THE PURPOSE OF SUPPORTING THE STRATEGIC DEMOLITION AND SMART GROWTH IMPACT FUND (2)

Resolution of the City of Aberdeen to approve the application (the "Application") and financing for a Strategic Demolition and Smart Growth Impact Fund project in the City of Aberdeen, Maryland (the "Project"), to be funded by the Department of Housing and Community Development of the State of Maryland (the "Department"), or through other departments or agencies of the State of Maryland.

WHEREAS, the City of Aberdeen recognizes that there is a significant need for reinvestment and revitalization of the communities in Harford County/Aberdeen; and

WHEREAS, the Department, through Strategic Demolition and Smart Growth Impact Fund or other programs of the Department, or in cooperation with other State departments or agencies, may provide some or all of the funding for the Project (the "Project Financing") to make the Project financially feasible; and

WHEREAS, the Project is located within a designated priority funding area under Section 5-7B-02 of the Smart Growth Act, is located in a Sustainable Community, as identified in the Sustainable Communities Act of 2010, and the Project will conform to the Aberdeen Development Code; and

**WHEREAS**, the applicable law and regulations require approval of the Project and the Project Financing by the City of Aberdeen; and

**NOW, THEREFORE BE IT RESOLVED THAT**, the City of Aberdeen hereby endorses the Project; and HEREBY approves the request for financial assistance in the form of a grant or loan, up to the amount of \$785,000; and
